Now, a little historical context -- Apparently, Richard and Anthorite Martin left Orange Co, VA about 1764, the same time that Thomas and Eleanor Graves Kimbrough (and I believe Leonard and Sarah Kimbrough

Brown) left Orange County, VA. Once in Orange Co, NC, I feel sure that they all filed for land grants. However, the early Orange County, NC land records were buried in the ground and destroyed. So, we lack records from 1764 to 1777 when Caswell became a county. Once Caswell became a county, the land records were reestablished in Caswell County. But, I feel confident most of these folks were there much earlier. By the time Anthorite Martin files her land grant (1787), Richard has died. In fact, there is a 1783 land record showing Anthorite Martin as living adjacent. Remember that Robert Martin of Orange Co, VA wrote his will in 1781 and mentions the heirs of his son Richard Martin. So, Richard died bef 26-Sep-1781. Richard and Anthorite had at least two sons: Richard Martin and Robert Martin.
