become a sewing and surveyors appoint Per Håkansson in Ämtebjörk and Per Håkansson in Backa.

Between Per Jonsson in Backa plaintiff and Arvid Olofsson in Mjönäs as guardian of the deceased corporal Brandbergs left minor son Kristoffer Pettersson respondent, as well as Johan Arvidsson its co-guardian, regarding Per Jonsson's demanded payment for what he slightly over 2 years of age gave birth and cared for the same Kristoffer Petters, was dismissed, the court tries reasonably well that unless the same Kristoffer Pettersson can remain in the service of Per Jonsson for as long as he can with his service (?) pay all the cost Per Jonsson (?) on the same Kristoffer's subsistence had before he can do any useful service, Per Jonsson can reasonably not be impressed that from the same Kristoffer Persson's property as long as it can adequately receive a legal compensation of 20 dlr smt for each year he has had with him, and still be gardens, to the same Kristoffer can reach the age where he can afford food and clothes. Incidentally, as Per Jonsson undertakes to receive on such a condition the same Brandberg's son with its small property to bestow as guardian (?) Him and its property: for the court reasonably obeys the same Kristoffer Persson's previous guardian's claim, to dismiss them from guardianship for him, and that in its place entrust the same Per Jonsson, who therefore has the right to receive and in the most justifiable way understand and manage the guardianship for him, preferably Per Jonsson is so closely indebted to the same Kristoffer as these his former guardians.
