Seth Devine married (first) November 8, 1848, Margaret B. Griffin, born October 27, 1824, died January 24, 1878, daughter of Bartholomew Griffin. Married (second) Mrs. Louise Harris, in 1880. Children: 1. William G., born August 8, 1850; married (first), February 10, 1873, Alice Freeman; (second), Ella Baker; children by first wife, Alice L. and Mary Ethelyn. 2. Hannah, born March 12, 1851; married Charles A. Langdon; children: Herbert, Elizabeth, Charles. 3. George S., see forward. 4. Maria G., born September 4, 1856. 5. Elizabeth M., born June 29, 1862; married George M. Mend; son Arthur D. & Charles, born March 22, 1866; married Emily Stover; son Stover.

(III) George S., son of Seth and Margaret B. (Griffin) Devine, was born in the town of Kingsbury, Washington county, New York, February 2, 1853. He was reared on the home farm, and was educated in the schools of Sandy Hill and at Fort Edward Collegiate Institute. He remained with his father as his assistant for a few years, then began farming on his own account, soon, however, relinquishing that business and entering mercantile life. For several years he operated a grocery store in Sandy Hill; then engaged in the market and dry goods business, finally concentrating all his energies into the latter, which he still continues in Hudson Falls. He served three terms as deputy sheriff of Washington county, then was out of office during the year 1900. In 1910 he was again appointed, and is still serving as deputy. He has been tax collector and served in various other public capacities. He was elected first president of Hudson Falls after the name was changed from Sandy Hill. He is a member of Free and Accepted Masons and a Republican in political preference. He married, January 22, 1879, Althen A., daughter of William and Althea A. (Bishop) Brayton (see Brayton VII). They have no children.

The earliest known paternal ancestor of Mrs. Althen A. (Brayton) Devine is Francis Brayton, born 1613, died 1662. He was of Portsmouth, Rhode Island, in 1631, when "he was received as an inhabitant, gave his engagement unto the government and proponed for a lot of land." He was made a freeman in 1633. In 1634 he was a commissioneer; in 1657 enlisted in a troop of horse; in 1669-70-71-72-73 he was deputy to the general court. September 1, 1688, he was

convicted to appear for selling drink to Indians on the first day of the week, and confessed in court the fact and referred himself to the justice of the court, and was fined ten shillings. His wife Mary died about 1654. Children: Francis, see forward; Mary, married Joseph Davol; Stephen, died 1691; married, 1679, Ann Tallman; Martha, married John Pearce; Elizabeth, died 1718; married Jared Bourne; Sarah, married Thomas Cudwell.

(II) Francis (2), eldest son of Francis (1) and Mary Brayton, died January 30, 1710. He was also an inhabitant of Portsmouth, Rhode Island. He was a farmer and a prominent land owner not only in Portsmouth, but in the neighboring town of Tiverton. His will was proved February 12, 1710. He married, March 18, 1671, Mary Fish, who died April 4, 1747, daughter of Thomas and Mary Fish, who were at Portsmouth as early as 1643. Thomas Fish was a member of the town council of Portsmouth in 1674. Children: Mary, born January 1, 1676, died 1742, unmarried; Thomas, see forward; Francis, born March 17, 1684, died April 22, 1740; married Sarah Sherman, and had a son; David, born October 23, 1686, unmarried; Mehitable, born January 12, 1693, died in 1742; married William Earle, and had three children; Benjamin, born September 8, 1695, died April 2, 1749; married Mary Battis and had five children.

(III) Thomas, oldest son of Francis (2) and Mary (Fish) Brayton, was born June 14, 1681. His will was proved in 1758. He was a resident of Portsmouth and East Greenwich, Rhode Island. He was a wealthy man, as by his will he disposed of farms, houses, slaves, vessel and personal property. He married, August 23, 1704, Mary Freeborn, born August 24, 1679, died 1761, daughter of Gideon and Mary (Lawton) Freeborn. Gideon Freeborn died in 1739; he was a son of William Freeborn, born 1692, died April 28, 1700, and Mary, born 1713, daughter of Matthew and Eleanor Bostrom, of Newport, Rhode Island. Children: Mary, born July 1, 1711, married James Gifford; Hannah, born March 28, 1711, married Henry Straight (2); Thomas, born July 21, 1713, married Mary Phillips; Francis, died in infancy; Gideon, see forward; Francis, born March 30, 1721; died May, 1784.

(IV) Gideon, son of Thomas and Mary (Freeborn) Brayton, was born January 27, 1718. He married Anneeca Nichols, and had children: Thomas, see forward; Gideon, born March 17, 1744; Joseph, July 15, 1747; John, December 14, 1750; William, November 19,

1736; Matthew, July 24, 1759; Rebecca, June 5, 1761, married Matthew Randall.

(V) Thomas (2), son of Gideon and Rebecca (Nichols) Brayton, was born March 11, 1741. He settled in Dutchess county, New York, and married, April 9, 1762, Emma Straight; children: David, born 1763, married Sarah Jenkins; Thomas, 1764, married Phoebe Godfrey; Henry, 1766, married Mehitable Wallace; Elizabeth, 1768, married Silas Cotton; John, see forward; Sweet, 1772, married James Black; Emma, 1775, married Supply Butterfield; Mary, 1777, married Russell Cole; Sarah, 1779, married Samuel Cook; Hannah, born 1781, married Charles F. Corbin; Silvia, 1785, married Alpheus Underhill; William, 1788, married Arvilla Corbin; Pierce, 1793.

(VI) John, son of Thomas (2) and Emma (Straight) Brayton, was born May 21, 1770. He removed to Warren county, New York, settling in the town of Queensbury, where he followed the pursuits of a farmer. He married, in Dutchess county, Mary Harris, born April 9, 1773. Children: Samuel, born December 27, 1791; Henry, October 2, 1793; Lois, June 27, 1795, married Palmer Justiss; Moses, November 4, 1797; Phoebe, October 15, 1799, married Levi Andrews; Sylvia, September 23, 1801, married Benjamin Carpenter; William (see forward); Asa, July 9, 1803, married Polly Phillips; Orilla, January 27, 1808, married Sylvia Sheldon; Mary, May 11, 1810; Charity, June 3, 1812; Diana, May 11, 1813.

(VII) William, son of John and Mary (Harris) Brayton, was born in the year of Queensbury, Warren county, New York, July 10, 1803. He was educated in the town schools, and was reared on the farm which he left to assume control of his own estate in Kingsbury, Washington county, New York. Here he remained several years, finally disposing of his property in Queensbury, and removed to Kingsbury, and later removed to Fort Edward, New York, where he purchased a farm. Here he died February 11, 1889. He married, March 22, 1837, Althea A., born June 14, 1814, daughter of Jesse and Mary (Griffin) Bishop. Children: Bishop, born July 15, 1838, died July 1, 1892; Harrison, May 2, 1840, married Janet Barclay; two children: William Lester and Edward Corey; Luina, August 11, 1841, married Emma Moore; children: William, Robert, Edward, Frank; Adelalde, May 23, 1845, married Gerard Ramsey; children: William, Harry, Adelalde (2); Cordelia, October 31, 1846, married Arthur Ramsey; children: Arthur, Bertha, Gilbert, John W., Sep-

tember 29, 1849; Athene A., August 1, 1854, married George S. Devine.

The Amsterdam family of McFARLAN McFarlan are of Scotch descent, and have inherited the untiring energy that is an invariable Scotch asset, which, added to their hard, determined nature, makes them desirable members of any community in which they settle. The American founder of this particular family was Archibald McFarlan, born in Perthshire, Scotland, about the year 1770. He remained in his native country until he had reached the age of twenty years, when he emigrated to the United States, arriving in the year 1790. He settled in Fulton county, New York, in the town of Peru, then Broadalbin, afterward named in honor of the many Scotch settlers from Perthshire, Scotland, who had made their homes in that section. The country was at that time mostly virgin territory, inhabited only by the wild things of forest and stream, with an occasional farm wrested from the wilderness by the hardy pioneers. Into this region he came, and securing a tract of land began the clearing of a farm. His tract was heavily timbered, but in the end was converted into a fertile farm, on which he died September 25, 1837, after an American residence of forty-seven years. He married, in Fulton county, New York, October 14, 1793, Isabelle Robb, born in Perthshire, Scotland, September 28, 1774, died August 18, 1836, daughter of an old Scotch family of Perth. She came to the United States with her brothers James, William and Peter Robb, about the year 1794, settling on lands in the town of Peru, where she was married to Archibald McFarlan. Children: 1. Alexander, born December 20, 1794, died August 13, 1832. 2. Margaret, February 23, 1797, died January 16, 1837, married James Stewart, who afterward removed to Michigan, where he died, leaving a family. 3. Jeanette, April 14, 1799; died unmarried, April 6, 1845. 4. Patrick, see forward. 5. Isabella, April 19, 1801, died in 1861, at Vail Mills, Fulton county. She married William George, a farmer of Mayfield, who survived her six years. They left a son Archibald George, who married Emily Waite, daughter of Greene Waite, a well known politician of the state, at one time Post Warden of New York City. With his father-in-law, Archibald George, he built and for many years conducted the hotel "Sir William Johnson," at Johnstown, New York. 6. Archibald (2), July 4, 1804, died in Johnstown in 1875; was a successful attorney of the county. He married Jane
