- LOAN, Benjamin married Ann R. P. Duvall. Surety, Arthur Hall. January 20, 1792.
- LOCKERT, Eli married Amey J. Lacy, daughter of Batt C. Lacy. Surety, Thomas J. Lacy. Consent filed with bond. Witnesses, Thomas J. Lacy, Richard Emmons. July 2, 1823.
- LOGAN, James married Mary Stayton, daughter of Thomas Stayton. Surety, Walter Stallard. Consent filed with bond. Witnesses, William Riggs, Thomas Huey. February 21, 1789.
- LONG, Griffin married Sarah Graham, both being above the age of 21 years. Surety, Jacob Yoder. August 18, 1801.
- LONG, James married Nancy Brown, daughter of Coleman Brown. Both James Long and Nancy Brown were above the age of 21 years. Surety, William Hunter. January 29, 1811.
- LONG, John married Mary McKee, daughter of James McKee. Surety, Ralph Cotton. Consent filed with bond. Witnesses, Jacob Yoder, William Adams. August 4, 1789.
- LONG, John Slaughter married Elizabeth Foster, daughter of Anthony Foster. Surety, Anthony Foster. February 10, 1804.
- LONG, Nimrod married Rcsanna C. Foster, daughter of John Foster. Surety, John Foster. January 14, 1808.
- LORD, Hesekiah married Caty Pursley, daughter of Thomas Pursley, and above the age of 21 years. Surety, William Owens. January 2, 1793.
- LORIMIER, William married Rosanna Kean, daughter of Patrick Kean. Surety, Matthew Cain. Consent filed with bond. Witnesses, Matthew Cain, Charles Bodine. July 24, 1815.
- LOUDOUN, John married Dorcas Masterson, daughter of John Masterson. Surety, John Masterson. Consent filed with bond. Witness, Joseph Carter. April 11, 1795.

RICHIE, John, Jr.	married Nelly Jupin, daughter of John Jupin. Surety, John Jupin. December 9, 1807.
RICKET, Zachariah	married Sarah Philips, widow. Surety, Benjamin Grayson. March 8, 1792.
RICKS, John	married Anna Marshall, daughter of William Marshall. Surety, William Marshall. August 12, 1796.
RICKS, John	married Mrs. Frances Stone. Surety, Jesse Stone. November 21, 1823.
RICKS, John M.	married Mary Hobbs, daughter of Joshua Hobbs. Surety, Joshua Hobbs. November 1, 1823.
RICKS, Thomas	married Elleanor Marshall, daughter of William Marshall. Surety, William Marshall. February 5, 1792.
RIDGWAY, John	married Margret Crume, both being above the age of 21 years. Surety, Thomas Sweets. October 18, 1807.
RIGGS, Stephen	married Elizabeth Riggs, an orphan and sister of James Riggs. Surety, James Riggs. July 20, 1812.
RIGGS, William	married <u>Ann Stayton, daughter of Thomas Stayton.</u> Surety, John Steele. Consent filed with bond. Witness, Jacob Cassalman. February 28, 1788.
RIGHTMIRE, Cornelius	married Elizabeth Finch, daughter of John Finch. Surety, Cornelius Neafus. Consent filed with bond. Witnesses, John Bodine, Cornelius Neafus. August 28, 1805.
RILEY, Bailey	married Polly Bridwell, daughter of Presly Bridwell. Surety, Presly Bridwell. Note: An instrument signed by George Dawson may have been intended as a consent for Bailey Riley; however, it makes so little sense that its purpose is doubtful. Witnesses, Cuthbert Bridwell, Simon Bridwell. December 31, 1812.
RILEY, George	married Sophia Dawson, daughter of Bailey Dawson. Surety, Bailey Dawson. May 24, 1821.
