Spouse: **Bärtil Hendricksson**. By 1661, Bärtil moved to the Sassafras River in Cecil County, MD where he patented a track called "None So Good in Finland". On March 4, 1668/9 he sold his Cecil County land and joined his brother Peter in Crane Hook. As Bartle Parker, he was fined 100 guilders for his part in "The Long Finn Rebellion of 1669. Returning to Cecil County in 1674, he acquired the tract "Indian Range" where he died in September 1682. He was survived by his wife, Margaret and sons Matthias, Hendrick and Bartholomew.

Lived at: 1661, Sassafras River, Cecil Cty, MD

On the division of Pal Jonsson's estate, it was agreed that Margareta and her husband would receive 150 A. of "None So Good In Finland". In 1668, Bartil traded his share of this plantation to John Cocks for his 200 A. tract known as "Cock Crows Thrice" and later added a 100 A. tract known as "Indian Range".

Cornelius sai 150 eekkeriä "Not so good in Finland"-nimisestä tilasta, jonka hän möi 1669 John Cockille.

Cornelius, born in Sweden, also arrived on the ORN, (Eagle), in 1654 with his father Peter Mansson. On the division of Pal Jonsson's estate, Christina and Cornelius received 150 Acres of "None So Good In Finland", which was sold to john cocks in 1669. Cornelius died childless soon thereafter. IV Andrew (Anders, Antti) Pålsson Mullica, Poulson, farmer, b. 1640 Sweden, Mora, Delsbo, d. after 1690 Maryland, Cecil County. Andrew hankki 50 eekkerin tilan Elk Riverin läheltä vuonna 1662. Hän eli vuosina 1683-1690 suomalaiskylässä, jonka nimi oli Sahakitko. Hän myi tilansa vuonna 1690 ja hänen nimeänsä ei löydy kirjoista vuoden 1692 jälkeen.

Andrew (orginal name Antti), with his parents, emigrated from Sweden to New Sweden, (now Wilmington, Delaware) aboard the ship ORNEN, (EAGLE), in 1654. It must be noted that Ander's area of origination was near Mora, which is in Dalarna, Kopparbergs Län. This event was reported, however, by the member church parish at its headquarters in Delsbo Parish, in Hälsingsland, Gävleborgs Län.

He accompanied his parents in their move to Cecil Cty, Maryland in 1661, known as Andrew Mullica, where he was naturalized on Nov 6, 1683 as "Andrew Poulson alias Mullock", (this a respelling of the family name, Malich/Mullikka). This was recorded in Kilty's LAWS of MARYLAND, Chapter IV, 1683: An Act Naturalizing Andrew Poulson, (alias Mullock, Swead) and their children. This Act was also reported in the ARCHIVES of MARYLAND,
