February, 1670/71, names daughters Elizabeth and Ann and in his memo (codicile) he names his son Woodman (Accomack Co, VA Orders 1671-1673, pg. 231).

Virginia's Eastern Shore, Whitelaw, Ralph T., Peter Smith, Gloucester, MA, 1968, pg. 1267: (Accomack County A148) "1692 Henry and Elizabeth Toules sold the south 207 acres" of the 500 acres he bought from William Kendall in 1690. The balance of 283 acres was another sale in 1715 by Henry and Elizabeth Towls.

Wills and Administrations of Accomack County, Virginia 1663-1800, Nottingham, Stratton, Heritage Books, Inc., Bowie, MD, 1990, pg. 37: ELIZABETH STRATTON (widow of John Stockley and John Stratton), in her will writted 17 June, 1697, names her daughter Ann Atkins, along with Joseph, Matilda and John Atkins and in the Will she names Henry, Jr., Stockly, Thomas, Job and Condal (Kendal) Toles (Towles). (Accomack Co., VA Wills & ect. 1692-1715, pg. 422)

NOTE: The daughter Ann was alive on 17 June, 1697 and named Atkins and apparently Elizabeth had deceased or was not named in the will for some reason.

NOTE: Woodman Stockley and William Atkins were brother-in-laws.

3. JOHN1 Stockley was born about 1622 according to an affadavit made at Acconiack Co. Court on 19 Jan 1671 [1672] in which he gave his age as 50 years or thereabouts.25 He had come to the Eastern Shore at the "Cost & Charges" of his brother Francis in exchange for three years of service and first lived in what is now Northampton Co. where on 5 June 1640 he testified regarding Jane Paramore, wife of John Paramore, who had accused John Deereman of being a "Ruffian. ..and Robber." 26 By 29 Aug 1642, he was a "Taylor" and ordered to pay William

Stevens, Boatewright, fifly pounds of tobacco for "the spoyleing a Frize shute of Cloathes..." and Stevens was ordered to pay John for matking the suit.27 He served as a juror during this period and was fined in 1643 for profanity, as was his brother Francis.

By 1655 John's status had changed materially. He had very likely returned to England at least once during the years as he and Francis were given as headrights in 1651 by Jonas Jackson. He had by some means, perhaps inheritance from either his family or that of his wife Elizabeth, acquired sufficient capital to purchase 400 acres at the seaside in Northampton from Capt. William Whittington for 4000 pounds of good tobacco and cask on 30 July 1655. He also owned 200 acres granted 30 Oct 1669 which he sold to Thomas Eastmed on 29 Aug 1670, both of these tracts being in present Northampton Co. His wife Elizabeth joined in this deed.28 The deed from Whittington was "lost or mislaid" when a complicated series of conveyances was recorded in Northampton on 17 Jan 1670 reciting that John had sold to Col. William Kendall this 400 acres for 6750 pounds of tobacco and 500 acres "to be laid out and conveyed to me...adjoining to the sd land belonging to me John Stockly..." William Whittington, son of William deceased, "out of dutiful care of my father's honor and reputation..." confirmed the sale to Stokely.29

John and Elizabeth moved up the Shore into the north end of Accomack Co. where as "Mr. Jno. Stokeley" he patented 2600 acres in Accomack on 2 Sept 1664 lying on the seaboard side bounded on the north by Corrattawaman Creek adjoining his own land and Col. Edmond Scarburgh. The list of the 52 persons he had transported included Eliz. Stockeley, Jno. Stuckley, Eliz. Stuckley and Jno. Stockeley. Thus John and Elizabeth had either crossed twice or the additional names could have been those of two of their children.30 The only portion of his "grand patent" sold by John Stockley before his death was a 200 acre tract to Xphr. Stanley, described as being on Poplar Neck and a branch of Assawamun Creek. This deed was dated 8 Apr 1671 and Elizabeth, wife to John, relinquished her dower rights on the same day.31

John Stockley had also acquired 500 acres from Col. Wm. Kendall by deed dated 12 Nov 1672

John Stockley had also acquired 500 acres from Col. Wm. Kendall by deed dated 12 Nov 1672, described as in or near Assawoman, so had a large holding in Accomack before he died.32 On 28 Nov 1673, shortly after John's death, Elizabeth Stokely "of the upper part of the County of Northampton als Accomack, relict of John Stokely Senr late of the same place," and William



Stokeley, "eldest son and heir of his late father," came into Northampton Co. Court to confirm the deed of John Stokeley, dec'd, of 200 acres in Northampton sold to Eustace Parsons, dec'd on behalf of Emanuel Hall "the

son of Emanuel Hall and now wife of Eustace Parsons."33 All of John's Northampton land was now sold and his family was thereafter principally found in Accomack Co.,. John Stokely, planter, "well of body. ..but mindful that man is frayle & his dayes passe away like a Shadowe," made his will on 3 Feb 1670 [1671], added a codicil on 18 Apr 1673 and it was prokited in Accomack Co. on 18 Aug 1673. He left his plantation of 2700 acres to be divided between such of his sons who survived at his decease, "to them and their heirs forever." Division was to begin at the northern-most bounds for the eldest son down to the youngest at age 21 if their mother were still a widow, otherwise at age 18. Stock was left to his sons and daughters Incy, Hanna & Anne when "they shall be marriageble, excepting daughter Elizabeth because I have already designed her portion." Various items were left to his wife Elizabeth and she, William Custis and Mr. Edward Revell were named executors. The codicil dated three years later stated that since he had already given "my 3 Sonns their shares of Cowes & Chattles, that is William, Woodman & John," they were not to receive additional stock. He also left outright to wife Elizabeth the neck of land which lay to the northward of Christopher Stanley. Wm. Custis and Thomas Bagwell witnessed his signature and proved the will. A note from Elizabeth Stokely to the "Worshipfull Gentlemen" of the Court asked that the will be put upon the records hecause she was not well at present and asked to be excused from attendance. This was dated 15 Aug 1673 and witnessed by John Stratton who presented it to the Court.34 Although all of the sons of John Stokely were not specifically named in his will, their later ownership of his lands makes it possible to identify them.

Elizabeth Stockley was born about 1633 or 1634, as she was aged 40 or thereabouts when she made a deposition on 8 Jan 1673 [1674] regarding her debt to Jno. Watts for 361 pounds of tobacco which she had thought to pay by selling a cow.35 Her maiden name remains unknown and John and Elizabeth were probably married about 1647, as their eldest son William is known to have been born in 1648/1649. She was a very young bride indeed.

Elizabeth Stokely sold her 100 acres of inherited land adjoining Christopher Stanley on 6 Jan 1673/1674 to Edward Vaughan for 3000 pounds of sound merchantable tobacco and cask 36 and married prior to 16 Apr 1675 John Stratton. On that same date Ince Stokely petitioned against her father-in-law [step-father] John Stratton for what was devised her by her father's will.37

On 19 Aug 1675 Jno. Stratton and his wife Elizabeth, formerly wife of Jno. Stokely, sold an additional 250 acres at the head of

Assawoman Branch adjoining Christopher Stanley, Edward Vahan and Coll.Kendall to James Powell.38 On 15 Aug 1683 William Stokely leased to John Stratton "for the compleat term of ninety and six years & he to pay King's rent" 80 acres adjoining Francis Stokely. William's heirs were directed to continue the lease for the full term and this lease figures in later land sales.39



Stratton appeared frequently in Accomack records for some years. On 20 Aug 1678 he attested to the Grand Jury that "John Stokely hath made breach of the Sabbath by talking & making a noise when the Minister was in Divine Service" and in Nov 1679 petitioned for the cost of a sloop lost "in the Service of the Countrie." In 1686 there was a dispute between Mr. John Stratton and William Stokely as to who should be guardian of Elizabeth Vahan, orphan, as Stratton was named in the will of her father and William was named by Elizabeth's mother. Elizabeth was content to remain with William until of age. On 20 June 1692 John and Elizabeth Stratton sold to John Lawes 200 acres in Forked Neck purchased by Stratton of Wm. Kendall.40 John Stratton, "sick of body," made his will on 1 May 1696, requesting that he be buried in the Churchyard of the Upper Church within five feet of the Church door. To Joseph Stockly he left "my great Bible of ye old translation and my Booke of divotion;" to Thomas Stockly "my other great Bible of new translation and Baxter's Call to ye unconverted." Francis Conner was left a looking glass and Elizabeth Tayler "the book I lent her." Elmer Messy and the heirs of her body were left "my plantation...80 acres out of my lease for the full terms of the lease" after the decease of wife Elizabeth, who was to have all his personal estate. Joseph Stokely and Thomas Stokely were named feoffees in trust and executors. The will was presented by Mr. Tully Robinson on 2 June 1696 for and on behalf of Mr. Alexander Messy who married Elinor, one of the legatees.41 The will of Elizabeth Stratton, "being weak in body," was written 17 June 1697, but not probated until 6 Aug 1707. Her legatees were: Joseph Atkins, son of daughter Ann Atkins; Matilda Atkins; John Atkins; grandson Woodman Stockly; Henry Toles Juner; Stockly, Thomas, Job and Kendall Toles; John, Francis, Thomas, Joseph, and Charles Stockly; Hanna Baley and the rest of her brothers and sisters. Though not all specified as such, it is obvious that these devisees were children of her daughters and her own living sons and each was bequeathed stock or household items. Witnesses were John Bradford, Henry (X) Ransom[?] and Mary (X) Sampell and Bradford and Sampell proved the will.42 There was no known issue by Elizabeth's second marriage.

As known from wills and later land records, the children of John and Elizabeth () Stokely were:

7 i. William Stockley, mentioned as eldest son when he and his mother sold land in Northampton Co. in 1673, was born about 1648/1649 according to three affidavits he made: aged 25 in Jan 1673/4; 32 in Dec 1680 and again in May 1681.43 He was guardian of his niece Elizabeth Vahan in 1683 and leased 80 acres of his land to his step-father John Stratton the same year. His wife Mary was named in his will dated 23 July 1686 and was to have his plantation for life. All personal estate was left to Mary and her heirs. His brother Joseph Stockley was named executor and the witnesses were John Stratton, Elizabeth Stratton and Tho. Perry who proved the will on 7 Oct 1686.44 Mary must have died prior to 21 June 1687 when Woodman, John and Thomas Stockley sold to their brother Joseph Stockley their shares of 40 acres each of William's land, "binding on Assawoman and land formerly Christopher Stanleys now in possession of John Bayly." The 80 acres William had leased for 96 years to John Stratton was not included in the sale.45

Text: 3. JOHN1 Stockley was born about 1622 according to an affadavit made at Acconiack Co. Court on 19 Jan 1671 [1672] in which he gave his age as 50 years or thereabouts.25 He had come to the Eastern Shore at the "Cost & Charges" of his brother Francis in exchange for three years of service and first lived in what is now Northampton Co. where on 5 June 1640 he testified regarding Jane Paramore, wife of John Paramore, who had accused John Deereman of being a "Ruffian. ..and Robber."26 By 29 Aug 1642, he was a "Taylor" and ordered to pay William

Stevens, Boatewright, fifly pounds of tobacco for "the spoyleing a Frize shute of Cloathes..." and Stevens was ordered to pay John for matking the suit.27 He served as a juror during this period and was fined in 1643 for profanity, as was his brother Francis.

By 1655 John's status had changed materially. He had very likely returned to England at least once during the years as he and Francis were given as headrights in 1651 by Jonas Jackson. He had by some means, perhaps inheritance from either his family or that of his wife Elizabeth, acquired sufficient capital to purchase 400 acres at the seaside in Northampton from Capt. William Whittington for 4000 pounds of good tobacco and cask on 30 July 1655. He also owned 200 acres granted 30 Oct 1669 which he sold to Thomas Eastmed on 29 Aug 1670, both of these tracts being in present Northampton Co. His wife Elizabeth joined in this deed.28

The deed from Whittington was "lost or mislaid" when a complicated series of conveyances was recorded in Northampton on 17 Jan 1670 reciting that John had sold to Col. William Kendall this 400 acres for 6750 pounds of tobacco and 500 acres "to be laid out and conveyed to me...adjoining to the sd land belonging to me John Stockly..." William Whittington, son of William deceased, "out of dutiful care of my father's honor and reputation..." confirmed the sale to Stokely.29

Planter, beinge well in body and of sound mind and memory, praised bee God for t, but finding that man is frayle & his days passed away like a shadow doe for ye peacable settings of that small Estate God hath ordained mee withall make and ordaine this to bee ny last will & testament revokinge all those formerly made.

Imprimis I bequeath my soule to God that gave it hopinge through the meritt of my Saviour Jesus Christ to obtaine forgivenes of my sins & salvation in ye world to come (?) I bequeath my body to ye earth decently to be aburied at the discreshion of my Executrix hereafter named.

Item for my worldly good & estate my debts beings paid I give & bequeath as followeth-

I give & bequeath my plantacon att Assowamon beinge two thousand seven hundred acres of land unto such & all of ny sons as shall be surviving at my decease & to their heirs for ever the said land equally to be divided between them, abeginninge with the oldes Son and soo down to ye youngest the division to begin att ye northermost bounds & soo downwards to the southward every one according to his age makinge ye next share the division to bee made by themselves if they can agree or by such as at my decease I shall desire to see ye same friends each of them to take his share at ye age of eighteen years if provided I and ny wife bee both dead. But if my wife shall survive & remain a widow then neither nor other to have his part until they attain ye age of one and twenty years then to have the mesuage of them their Estates till that time.

Hanna & Anne when beinge at such time at every of them shall attain to age (that is to say) if there be one creature for a son there must bee two for a daughter. I doo not here mention my daughter Elizabeth because I have already devised her portion my (intention?) is in sharinge ye herfors to devide them equally amongst them.
