This Indenture made the fourteenth day of December in the year of our Lord one
 thousand seven hundred and ninety five Between Henry Brock and Mary his
 wife of the County of Shenandoah and state of Virginia of the one part and Michael
 Brock (son of the said Henry Brock of the same County and State of the other part
 Witnesseth that for and in consideration of the sum of one hundred pounds current
 Money of Virginia, to the said Henry Brock in hand paid by the said
 Michael Brock at or before the sealing & delivering of these presents, the Receipt
 whereof he doth hereby acknowledge I shew doth when I acquit & discharge the
 said Michael Brock, his Executors and Administrators by these presents, they the
 Henry Brock and Mary his wife have Granted bargained sold aliened released and
 Conferred and by these presents do Grant bargain sell alien release and confer
 unto the said Michael Brock and his heirs a certain Tract piece or parcel of Land
 Lying and being in the said County of Shenandoah on a branch of Holmans
 Creeke it being part of a tract of two hundred and sixty eight Acres of Land which
 was granted to the said Henry Brock by deed from the late proprietors office of the
 Northern Neck of Virginia bearing date the seventeenth day of March in the year of
 our Lord one thousand seven hundred and fifty two and that part thereof which
 is hereby Conveyed to the said Michael Brock is bounded According to a division
 Survey thereof made as followeth to wit Beginning at three black oak Saplings
 a Corner made for Rudolph Brock in a line of the Intire tract and extending
 thence with the old Line (Reversed) West one hundred and thirteen poles to some
 Marked Corner trees on the south side of a branch of Mill Creek thence South seventy
 poles to a Stake near the Waggon Road Corner to the Land which formerly did
 belong to Peter Gortner then the same Course continues with his line Ninety
 poles to two white oaks in the said Line then Crossing the Intire tract N 65 E
 seventy one poles to two black oaks then N 79 E fifty poles to a Stake near
 a Walnut tree and some Limestone Rocks then N 77 E seven and a half

poles to a Cherry tree then N^o 75 E thirteen poles to a stake by a Spring branch and near
 the head of another Spring then S 78 E sixty poles to two white oaks and a black oak
 in the old Lane then with the same (reversed) North twenty three poles to a Stake by a


