There is reason to believe that there was also a son named John, but there is no definite proof. He could well be one of several John Wilkinsons shown in other counties nearby. One John Wilkinson was a Private in Co. 4, 3rd Virginia Regiment under Capt. John Blackwell, April 1, 1778 (Shaffell's). Another John Wilkinson enlisted in Lunenburg County, and served two years in the 5th Virginia Regiment under Capt. James Johnson. This man left a Will in which he is called "John Wilkinson; Jr.":

Lunenburg County Will Book 8, p. 352, June 1835—He names his children: Benjamin Wilkinson, Elizabeth Satterfield, Sally Briggs, Martha Ogburn, John Wilkinson, William Wilkinson and Ann Featherston.

There is evidence that John Wilkinson, Senr., gave material aid to the Army in the War for Inlependence. In January, 1777, he furnished a gun for Capt. Dixon's Militia Company. On October 7, 1777, he furnished provisions for Capt. Thomason's Co. for the Cherokee Expedition.

After the Will of John Wilkinson, Senr. was proved, Jane Wilkinson, his wife, refused to abide by it: Will Book 2, p. 328-

"I, Jane Wilkinson, of the County of Amelia, hereby renounce, refuse and disclaim all or any devise, provision, legacy or appointment which I can or may have right to claim by or under a written Will of my late husband John Wilkinson, deceased, and dated December 18th, 1773. And declare myself dissatisfied therewith and therefore claim instead thereof the dower and distributive share appointed for me by law.

At a Court held for Amelia County Feb. 24, 1780. On petition of Stephen Wilkinson it is ordered that Peter Lamkin, Gent., John Doswell, Wm. Doswell, and Elisha Betts, or any three of them do lay off and assign unto Jane Wilkinson widow of John Wilkinson, dec'd her dower in land and slaves whereof the sd. John Wilkinson died possessed and also her third of his personal estate and that they divide the residue of the cstate of the said John amongst his legatees agreeable to his last Will & Testament & make report to the Court.

Agreeable to the within order and by consent of the widow and other parties, we have divided the land of the deceased John Wilkinson as between Benjamin & Stephen Wilkinson. Beginning at Wade's Bridge on Great Nottoway thence down main road—property on north side of road to be Benjamin Wilkinson's —and all on the south side to be Stephen Wilkinson's—Widow Jane Wilkinson to have negro man George during her liftitme—Benjamin to pay her 800 pounds yearly of tobacco & Stephen is to pay Jane Wilkinson 800 pounds tobacco yearly during her lifetime. October 17, 1780.

Due to the lack of records covering the period after Stephen Wilkinson's land and home place were in Nottoway County (that is after 1788), the facts concerning his immediate family have not been established, nor has it been proved that he left Nottoway County. However, the record contained in the Bible of John Frederick Wilkinson who was born in Charlotte County, Virginia on December 9, 1834, and who died in Boone County, Missouri on March 3, 1898, who was the son of Samuel Wilkinson, who was born May 20, 1787 in Amelia County, Virginia and died in Warren County, Missouri on October 7, 1855, who was the son of Stephen Wilkinson, and which Bible was purchased sometime around the year 1850, is as follows:

"Stephen Wilkinson was buried in Charlotte County, and although his grave has not been located, the writer holds to the opinion that the above notation is correct.
