


The following items were found in a book titled "Georgia Newspaper Clippings Volume 1 1809 - 1834" in the Heritage room at the Public

Library in Eaton, Putnam County, GA. :

Wed. December 16 1812 - Putnam County, GA, Superior court, September Term 1812 - Rule NISI. Upon petition of David B. Mitchell, Governor, Praying the forclosure of the equity of redemption in and to certain fractional surveys of land lying and being in the county of Putnam known in the plain of the third district of Baldwin County by No. 63, mortgaged by John Lewis of Warren County, unless the aforesaid do pay into the clerk's office of this court the amounts due, within 12 months, the equity of redemption in and unto said mortgaged premises be foreclosed. Signed, William Williams, Clerk.

Wed. May 31, 1815 - On this first Tuesday in July next, will be sold at the court House in Eaton, the following Property, wit - 202 1/2 acres of land, fraction No. 63, in the 3rd district of Baldwin, now Putnam County, levied on as property of John Lewis to satisfy an execution in favor of the State. Signed, William Varner, Sheriff. - Info. per Bob Green on Sept. 23, 2003
