Page 174 Indenture 10 May 1795 ABNER LOOMISS and SOLOMON LOOMISS, for selves & for __ LOOMISS & JESSE LOOMISS, brothers & devisees of DOCTOR JONATHAN LOOMISS, late of Washington, North Carolina, to JOHN GRAY BLOUNT of sd town & state. Jonathan was seized of 1970 acres in Davidson County, being northern 1/2 of 3940 acres granted by North Carolina to him 14 Mar 1786, as reward for military services. Jonathan's will dated 20 Oct 1793, & left 3/4 property to his brothers, etc. Wit: BENJ A BLACKLEDGE, WILLIE BLOUNT.

Page 175 Indenture 23 June 1795 ELMORE DOUGLAS, to WILLIAM EDWARDS, 200 pounds, tr of 320 acres on N side Cumberland River on Middle fork of Station Camp Creek, beg NW cor of JAMES WINCHESTER & GEORGE WINCHESTER. Wit: WILSON CAGE.

Page 176 Indenture 7 July 1795 WILLIAM CAGE, Shff, to MICEAL GLOVER, latter of Davidson County, property of ROBERT DAUGHERTY recovered in suit in 1794, tr on S side of Cumberland on Spencers Creek, 640 acres, L62. Wit: None.

Page 177 Indenture 23 June 1795 CATHERINA BLEDSOE (signed CATY BLEDSOE), Exctrx will of ISAAC BLEDSOE, Decd, to JAMES SANDERS, of Caswell Co, North Carolina, \$4.00, 228 acres on Trace Fork of Trammel's Creek, tract orig granted Sanders and Isaac Bledsoe by deed of 20 May 1793. Wit: JAMES WILSON, DANIEL SMITH.

Page 178 Indenture 7 July 1795 EDWARD WILLIAMS to ROBERT ELLIS, L200, tr on N side of Cumberland River on middle fork of Station Camp Creek, 100 acres & beg in E line of MARY BLACKEMORE. Wit: D SHELBY.

Page 179 Indenture 13 Feb 1795 & in Nineteenth year of American Independence GEORGE ALEXANDER, of Cabarrus Co, North Carolina, to JAMES DOHERTY of sd co & st, L40 currency of state aforesd, tr on S side Cumberland River on beg creek below mouth of Obeds River(?), being 500 acres, part of tr of 640 acres granted Alexander, assee of heirs of SAMUEL HAYS. Wit: WILLIAM MCINTIRE, HENRY SUTE(?), ABRM LANDERS, Jurat.

Page 180 Indenture 1 Aug 1795 THEODRA MALETT, of Davidson County to WILLIAM BETTS, \$300, 640 acres granted by State of North Carolina to ELIJAH ROBINSON, No 3307, & by him conveyed to Malett, beg on waters of Caney Fork SW cor of Robertson tr as assnee of ROBERT NELSON. Wit: V P HARDIMAN, SETH LEWIS.

Page 181 Indenture 10 Sept 1795 JAMES WINCHESTER to ROBERT WILSON, \$120, tr a part of land orig granted to CAPT JAMES INGLES(?) for service in Continental Line of North Carolina, being on waters of Bledsoes Creek, beg at SW cor preemption granted orig to ROGER TOPP, abutting line of HENRY LOVINE, & being 132 acres. Wit: JAS A WILSON, JOHN WHITE.

Page 182 Indenture 2 Sept 1795 MARY GILMOUR, widow of late CHARLES GILMOUR, Junior and LANSFORD LONG, Gdn of CHARLES GILMORE, an Infant under age of 21 yrs, for sd Infant, to HENRY HYDE all of Halifax Co, North Carolina, for 5 shillings, several tracts on waters which were formerly of this State (near Cumberland River), being 640 acres in Davidson County, 640 acres in Tennessee County; also 640 acres more in Davidson County on N side Cumberland River near lower rd leading from Nashville to Red River (and

other land extensively described). Wit: MCRUNNIE LONG(?), JOSEPH EUBANK, Jurat.

Page 183 Indenture 13 Apr 1795 SAMUEL SAMFORD, of State of Georgia, by BENJAMIN SHAPARD, his atty, of Glasgow County, to SAMPSON WILLIAMS, for consideration of Williams having located 24 land warrants of 640 acres each for him (Sanford), assee of sundry persons, being in all 15,360 acres, conveys to Williams 1/3 part sd lands, being 8 grants of 640 acres. Wit: RD BLACKLEDGE.

Page 184 Indenture 4 May 1795 JOHN YOUNG to ROBT JOHNSTON, \$200, 365 acres on a branch of Drack waters of Barren, being 1/4 miles above SIMEN KUYKENDELL Camp. Wit: BLEAHAM LANDERS, Jurat, RICHARD CAVIT.

Page 185 Indenture 25 Nov 1794 WILLIAM FORT & HOWEL TATOM, both of Mero Dist & Terr of US S of Ohio River, to WILLIAM PRYOR, \$100, 320 acres on N fork of Red River. Wit: ANDREW JACKSON, Jurat.

Page 186 Indenture 21 Nov 1794 Grantors as on p 185, to JOHN HANNAH, \$100, tr of 320 acres on N fork Red River. Wit: As above.

Page 187 Indenture 27 Nov 1790 MARTIN ARMSTRONG and wife MARY ARMSTRONG, Stokes Co, North Carolina, to GEORGE AULT(?), of co & st aforesaid, Lill, 640 (acres) on S side Cumberland River within bounds lately ceded to Congress by state of NC, beg lower end first bluff above PETER LOONEY Preemp. Wit: JOHN SHEUB(?), Jun, LYNARD AULT.

Page 188 Indenture 5 Oct 1795 DAVID LOONEY, to SAML GRAGG of St of Kentucky, \$700, tr on Station Camp Creek. Wit: PETER TURNEY, WM BRIGENCE.

Page 189 Indenture 7 Oct 1795 JAMES DOUGLASS, Shff, to THOMAS MURREY, of Davidson County, L15, land belonging to THOMAS WHITE, being tron branch that empties into E fork Goose Creek and being 640 acres. Wit: DAVID SHELBY.

Page 190 Indenture 9 Dec 1795 WILLIAM CAGE, Esq, Shff, to ROBERT HEATON, ENOCH HEATON, & THOMAS HEATON, Heirs of Est of AMOS HEATON, Decd, of Davidson County, land owed by SIMON WOOLART, by order of court. L120 consideration, 640 acres. Wit: HENRY BRADFORD, S WILLIAMS.

Page 191 Indenture 19 Dec 1795 Grantees as in above deed, to SAMPSON WILLIAMS, \$200, 320 acres near Great Salt Lick, being 1/2 tr orig granted SIMON WOODERT. Wit: None.

Page 192 Lease 29 Apr 1795 RICHARD HOGAN to ANTHONY METCALPH, tract for 7 years, bounded on one end by Hogan's N square of field fence. Wit: EDWARD METCALPH, MARY METCALPH.

Page 192 Indenture 10 Nov 1795 NICHOLAS PERKINS HARDEMAN, Shff for Davidson County, to HARVEY SMITH, part of land of GIDEAN LAMB on S side of Cumberland River & on Thomsons Creek, \$19.28. Wit: None.
