Page 41 Deed 14 Aug 1787 & in 11th year of our Independence WILLIAM ROSS, Pitt Co, NC, to JOHN PRIDIX(?), Worchester Co, MD, 640 acres in Davidson County on Red River, adj heirs of JOHN LARKEY on the E. Wit: THOMAS CREW, LUTHER HYDE, BENJN HUDSON. Ack in Humphreys Co, TN before DAWSEY P HUDSON, Ck, & certified by DAWSON P HUDSON, Ck Ct of Pleas.

Page 42 Deed 15 Jan 1814 DAVID BIGGS, Robertson Co, TN, to SAMUEL BRILEY, \$107, 45 acres on Middle fork of Red River, tr adj JOHN DORRIS, THOMAS SMITH, & HOGAN. Wit: THOS SMITH, WILLIAM BRILEY, SAMUEL SMITH.

Page 43 Deed 27 Feb 1814 ROBERT MOORE to THOMAS BLOODWORTH, \$200, 40 acres on W fork Station Camp Creek, a little above junction sd fork with E fork, part tr orig granted to WILLIAM MOORE. Wit: JOHN B JOHNSON, WILLIAM BLOODWORTH.

Page 44 Deed 14 Dec 1810 ALEXANDER RASCOE to JOHN HENLEY, \$47.50, 4 3/4 acres.

Page 45 Deed 28 Feb 1814 EDMOND BRIDGES to WEBB BLOODWORTH, \$410, 100 acres on W fork Station Camp Creek. Wit: MICHAEL GREEN, WILLIAM BLOODWORTH.

Page 46 Deed 7 Mar 1814 THOMAS CONNELL to JEREMIAH BELOTE, \$330, 66 acres on N side Cumberland River. Wit: JAS BINTLEY, JOHN BELOTE.

Page 47 Deed 3 Dec 1813 DAVID TULLOCH to MOSES HENRY, \$135, tr on E fork of W branch of Goose Creek, including a part of CHARLES DICKSON & WILLIAM WILLIBY former claims. Wit: CHAMP KEESEE, GEORGE KEESEE, WILLIAM HENRY.

Page 48 Deed of Partition _____ 1814 WILLIAM CAGE, JESSE HAYNEY, WILLIAM HALL, ALEXANDER GRAHAM & JAMES BLACKMORE, Commissioners, partition land between JAMES FEELIN & JOHN OVERTON, sd land being part tr granted by North Carolina by Grant 475 on Dec 28 1802, and being 300 acres.

Page 49 Deed 16 Sept 1814 MOSES CAVIT to JAMES RONEY, \$2400, 232 1/2 acres on Middle fork Red River. Wit: W B YOUNG, JOHN CALDWELL, Jurats, WILLIAM A TINNIN.

Page 50 Deed 19 June 1814 RICHARD T BRADLEY to J W BYRNE, \$500, 50 acres, being tr that JOHN WEATHERS deeded to RICHARD T BRADLEY the 12 Jan 1799, part sd Weathers preemp lying on Station Camp Creek. Wit: ISAAC BAKER, CHARLES MORGAN.

Page 51 Deed Same date and parties as in above deed, \$450, 24 3/4 acres. Wit: As above.
