The track of land I purchased of Edward Wats (exclusive of the land I sold Thomas Johnson) unto Thomas Robbins to satisfy him for a debt I am owing to the amount of £ 15, also on account of said Robbins being security for me for £ 15. My will is that Edward Watts do make said Robins a good and lawful right to said land. Also one parcel of land I purchased of Edward Pigg containing by survey 100 acres. Robins is to sell said land and if any money more than pays him the said debt then Robins is to return it to my wife and children.

Nicholas Porter and Edward Walls [sic] do make Thomas Johnson a write the land I purchased of them and sold Johnson. My friend Joseph Spencer executor.

Pages 511-12. Will of James Roach Senr., being very week and in a declining condition, dated 18 March 1777.

To my grandson James Roach after the decease of my loving wife Lettis Roach 600 acres whereon I now live and mill.

To my granddaughter Letty Roach the 224 acres lying in Orange County bought of John Manifield near the old trap.

To my granddaughter Sally Roach 400 acres bought of Thomas Porter which his wife has not made a right to and when Mrs. Porter makes a right to the land then John Kelly is to have a lease on that part whereon he lives for three lives on paying the usual rent to the olfin [orphan?].

My daughter in law Harn [?] Roach shall have one Negro

aged between twelve and thirty.

The rest of my Negroes, stock and household furniture equally divided among my three grandchildren James Roach, Letty Roach and Sally Roach when James Roach comes to the years of eighteen years old.

The executors having refused to act, administration with the will annexed is granted to Lettis Roach.
