To All whom these presents shall come: I William Lee of the County of Brunswick do send Greeting--know ye that the said William Lee for and in consideration of the love and Good will and affection which I have to my Grandson Peter Lee of the said County have given and granted and by these presents do freely, clearly, and absolutely give and grant unto the said Peter Lee one negro wench named Delphy with her child Seeman and her increase before and after the decease of the said William and Rebecca his wife, but after the decease of the said William Lee and Rebecca his wife the said Peter Lee my Grand-son may have full possession of the said negroes and not before, which said negroes with all the increase thereunto belonging, I do absolutely and clearly give and grant unto the said Peter Lee and to his heirs forever.

TO HAVE AND TO HOLD the said negro wench Delphy and her increase without any manner of condition, as their proper right and title to the only proper use and behoof of the said Peter Lee his heirs forever.

IN WITNESS whereof I have hereunto set my hand and seal this seventeenth day of October in the year of our Lord 1755.

Joel had been given 427 a. of land, and was allotted another 19 1/2 a. to being his total share to \$1080.

Aaron had been given 200 a. of land by his father, and was allotted another 267 a. to bring his total share to \$1080.

The children of Nancy Sasser, namely, Josiah, David, and William, were allotted 567 a. of land to make their share of the estate equal to \$1080.

On 18 July 1833, Westbrook Lee, a resident of Sampson County,
age 74, made a declaration on oath before the justices of Sampson
County to obtain the benefit of the Act of Congress of 7 June 1832.
(He said) I was born near Merkle Swamp, (Sampson County area),
on 14 December 175He died 4 March 1840
Westbrook Lee was the son of William and Ann Westbrook Lee.

He married Dicey Gainey about 1784.

LEE, William, Private, N.C. Militia and 2nd N.C. Continental Line Soldier was born 1764 to William Sr and Ann Westbrook Lee. Soldier inherited land from his father in Sampson county. He married Elizabeth who predeceased him. They left no heirs. When he died in 1826 his land was sold by his brothers, Westbrook, Noah, Sampson, Samuel and David.

Jesse Lee, son of (Long) David Lee and Martha Blackman was born
16 March 1767. He married Elizabeth Blackman, daughter of Joseph
Blackman. After his marriage, Jesse moved to Cross Creek (now
Fayetteville), N.C. There, he and his wife's father acquired and operated a stage coach company to Tarborough, N.C., a distance of 125 miles. It took 60 horses to make the round trip. Lee and Blackman also sailed merchant ships to and from the West Indies. In 1801, a N.C. Senate bill was passed to keep Jesse Lee from taking into his possession any property Elizabeth had or might acquire --He had left her about that time and taken up with another woman. Elizabeth died in 1811. Jesse then married Susannah Langston. He and Elizabeth had two sons born to their marriage. The other children were born to Susannah. All of Jesse's children were:

- 2- A son who was born about 1789 and died by 1811.

Jesse' will went to probate court, Sampson County, in Nov term 1831. He had died 6 Nov 1831

According to the book, "William and Peter Lee", page 19, by Lang and Long, Elizabeth Blackman was the wife of Jesse Lee and daughter of Joseph Blackman. The book lists the birth and death dates of Elizabeth as follows: Born: 18 March 1767, Died: 25 December 1811. Jesse married second in 1812, Susannah Langston. Learry L. Warren, Dunn, N.C..

LEE, Cato, Private, N.C. Militia, Revolutionary Army Accounts Soldier served in the N.C. Militia under the command of Col. Eaton, He received pay voucher # 1078 for a total of six shillings for his service. The account was settled in 1788.

Cato was the son of Peter Lee and Mary Cato and was born 1757 in Prince George County, Virginia. He removed to Duplin County, N.C. (the part that became Sampson) with the Peter Lee family before the War, and married about 1780 to Nancy Holland and they made their home in nearby Johnston County.

- 4- Cato Jr who married Elizabeth

Will of Batt Lee

In the name of God, Amen, I, Batt Lee of the State of North Carolina, and County of Sampson, being of sound mind and perfect mind and memory blessed by God: do this the 3rd day of March in the year of our Lord, one thousand eight hundred and thirty-four (Mar. 3, 1834) make and publish this my last Will and Testiment, in manner following (vis.)

FIRST: My executors to sell at public sale as much of perishable property as will satisfy all just debts and funeral charges.

SECOND: I give and bequeath to my son, James B. Lee, one dollar, Harriet Jernigan the wife of Lewis Jernigan to have one dollar: Lemuel H. Lee to

have one dollar.

I give and bequeath to my two youngest sons: Major D. Lee and Erasmus E. Lee to have four hundred and twenty-five acres of land, more or less, including the home plantation to be equally-divided between them to the best advantage of my wife Kezia Lee lifetime or widowhood, to be excepted on the sd. land. I give and bequeath to my two youngest daughters Susan Lee and Kezia Lee all of my land lying in Johnston County to be equally divided between them. I give and bequeath to my beloved wife Kezia Lee all of my negroes and perishable property. after paying my just debts; during her life or widowhood, and them to be sold at public sale and Susan Lee and Kezia Lee to have one hundred twenty dollars on account of their inferior lots of land, and then the sd. girls to share equally with the rest and the balance to be equally divided between all of my children with the exception before being divided Major D. Lee and Erasmus B. Lee to have a horse, bridle and saddle apiece, to be worth sixty dollars apiece. Also if my wife should die before my four youngest children become of age, they should be schooled out of the property before a division.

November Term, 1846

Recorded in WILL O Docket, pages 2322-4323

I, Peter Lee of the county of Sampson and State of North Carolina, being of sound mind and memory, but considering the uncertainty of Life, do

make, publish, and declare this my last will and testiment hereby revolking all former wills and testiments by me maid, viz:

FIRST: My executer hereinafter named shall provide for my body a decent burial, suitable to my circumstances in life, and pay all my funeral expenses and other just debts_____ coming out of the first money that shall come to his hands, of my estate.

I give and devise to my only living son PETER R. LEE. THE TRACT OR PARCEL of land land whereon I now live, on the west side of the . . .

It is my will do devise and I hereby direct that all that tract or parcel of land, on which my son, PETER R. LEE, now lives on the south side of the Mill Branch and on the east side of the ?idy Branch, together with another small parcel or tract? the ?idy Branch shall be sold at public auctionon a credit of one or two years and the proceeds equally divided between the following persons, vis. Jane (Lee) Saucer, wife of Lewis Saucer, Mary (Lee) Noles, wife of William Noles --- Pheribe (Lee) Lee, wife of Kedar Lee ---- Kitsey (Lee) Tart, wife of ?urney Tart-- -- Vianna (Lee) Lee, wife of Alpha Lee, AND Spicey I. and Pheriby A. Hudson to represent their mother and to them a share between them to equal to one share of the others, with the exception of (\$35.00) thirty-five dollars to be deducted from the share of Spicey I. and Pheriby A. Hudson, on account of an advancement made to their mother, This makes them all equal, they having had some advancements heretofore.

I hereby direct that all the residue of my estate of whatever character or description after paying my debts shall be equally divided between all my said daughters, but my two grandchildren before named are to have none of this residue...

And I hereby appoint my Lemon(probably)H. Lee Guardian of my two grandchildren Spicey I. and Pheriby A. Hudson, during their minority.

And I hereby appoint my trusty friend C or G arry Draughon executor of this my last will and testiment. I hereby revolk all other wills and testiments which I have made. In witness whereof I hereunto subscribe my name to affix my seal this ---- day of October, A.D. 1846.

LEE, Peter, Lieutenant, N.C. Continental Line Soldier was the son of 'old' Peter Lee (1734-1804) and Mary Cato (1737-1777) who moved to the Sampson County area from Virginia very early. He was born about 1760 in Virginia.

Soldier made his will 1 Oct 1846. In it he names his children:

- 1- Peter R., IV (1806-185-) who married Dicey
- 2- A daughter who was deceased but had married Hudson, leaving two small daughters.
- 3- Jane who married Lewis Saucer (Sasser).
- 4- Mary who married William Noles (Knowles).
- 5- Pheraba who married Kedar Lee (son of Lemuel).
- 6- Kitsey who married Furney Tart. And
- 7- Vianna who married Alpha Lee. Soldier's will was taken for probate at the Nov. term of Sampson County Court 1846.

Hill, Francis, Captain, N.C. Militia
Fought at the Battle of Moore's Creek Bridge and Northeast Cape
Fear River Bride.

Cited for his part in the war.

Lived in what is now Newton Grove in North Sampson County. Will submitted in 1801 by brother-in-law Joab Blackman. Married Mary Blackman daughter of Joseph.
