File C-1

Sept. 18, 1832 - John B. Cain appointed administrator of Succession. Estate consisted of notes and a judgement, viz: a note on James C. Cain \$700; another \$800; a judgement on D. P. Cain of \$535; one on J. B. Cain for \$750. No heirs except brothers and sisters, names not given.

MARY E. CAIN and MATILDA TILLERY, 1847 (Abram Womack Jr.) File C-1 Nov. 25, 1847 - Abram Womack Jr. appointed adm. of succession with Abram Womack Sr. security.

Nov. 6, 1847 - Inv. of the property held in Community between Matilda Tillery decd and her surviving husband Abram Womack Jr. and the succession property of Mary E. Cain decd. Sarah Ann Cain, a sister, is the wife of William K. Davis. Abram Womack Jr. is the tutor of the minors. Six slaves appraised at \$2475.00

SARAH S. CALMES, 1841 (Wife of William Calmes) File C-1

Mar. 6, 1841 - William Calmes represents that his wife Sarah S. Calmes died Jan. 29, 1840, in Miss., leaving the following minor heirs: Elizabeth Berry, Thomas Jefferson, John Calhoun, Napoleon Bonaparte, and Sumpter Hayne. Sarah was the owner at the time of her death by the will of her mother Drucilla Braselman of the state of South Carolina of: negroes in E. Baton Rouge Parish in possession of F. Duplantier, also 2 slaves in possession of Wm. H. Stone.

Apr. 21, 1841 - Inv. Jefferson Lea, Joseph S. Glasscock, appraisers; Henry Leonard and Peter H. Kemp - slaves valued at \$5825.

MAURICE CANNON, 1838 File C-1

July 15, 1836 - Avery Breed Quillon charged M. Cannon board May 1, 1836, to July 15, 1836 - \$22.50

July 16, 1836 - George Packwood charges: "To a raised top Coffin, lined inside and out \$50.00" Robert Young charged \$24 for 24 days work on the <u>Plantation</u>.

July 29, 1836 - Inv. 340 acres in co-partnership with the succession of Carmac Cameon (?) situated on Tickfaw River adjoining land of John George \$640.

BAYLESS CARDER, 1822 File C-1

Aug. 8, 1822 - William P. Willis J.P. of 1st Ward, St. Helena Parish, made inventory for total of \$689. Sept. 28, 1822 - Family meeting: Thomas Tycer, John Carder son of Bayless Carder, Parizade Carder surviving widow. The children are: John Carder, Elizabeth Carder wife of _____ Humbolt, Charity Carder wife of _____ Womack, Elias Carder, and Mary Carder.

Nov. 11, 1822 - Sale of property to: Benjamin Kay, Jr., Bonaparte Brauner, Elias Carder, William Watson, Pharoh Roach, Vincent Boivioque. Total \$644.87.

BAYNES and MARY CARTER, 1810 File C-1

July 14, 1810 - John Breed and William Watson bond unto James Carter, Nancy Carter, Elizabeth Carter, Lucy Carter - minors of Bayness Carter decd. Mary Carter is surviving widow.

Pet. of Caswell T. Todd that he married the widow of Bayness Carter decd in the year 1810 or 1811 and that the decd left 4 children: James, Nancy, Elizabeth, and Lucy Carter. Also by her marriage to petitioner: Lorenzo,

Adeline, Jackson, and Luticia Todd.

Jan. 1, 1820 - Family meeting decided that perishable property be sold. Real estate to remain - 640 acres on Amite River formerly owned by Baynes Carter and valued at \$1200. Slaves, cattle, household, etc., valued at a total of \$3152.

Oct. 20, 1820 - Pet. of Caswell Todd: His wife Mary Carter lately died; Bayness Carter died in 1810 or 1811; Mary Todd, alias Mary Carter, died in 1820. The children of Mary's first marriage receive 3/4 of landed estate and 1/2 of personal; the four children of Mary's marriage to Todd are given the remaining 1/3 of the landed estate, etc.

June 13, 1840 - Probate sale of land: 640 acres bounded W by Amite River, W by William Dennis, S by Thomas Nesom, E by William Dennis - purchased by Richmond Dennis for \$800.

Heirs of Baynes and Mary Carter: James, Elizabeth, Lucy, and Nancy Carter. Nancy md. James Robison; their 2 children are Eliza and James Robison who reside in Texas. James Carter also resides in Texas. Lucy Carter md. John Morgan in E. Feliciana Parish. Elizabeth Carter md. Joseph Davidson of Livingston Parish.

Mary Carter, the widow of Banes Carter, md. Caswell T. Todd. Their children: Lorenzo, Adaline, Virginia, and Jackson Todd. Jackson resides in Texas; Lorenzo, in E. Feliciana Parish; Adaline md. _____ Sommers. She is now a widow and resides in E. Feliciana Parish.

Jan. 29, 1838 - Henry Carter purchased land at sale for \$1800. No description given.

Mar 7, 1838 - <u>Family meeting</u>: Pharoah Carter, John J. Bankston, William Carter, <u>Jesse Redmong</u>, and Henry Carter. Pharoah Carter purchased the land on Apr. 21, 1838 for \$1860.

Dec. 30, 1840 - Pet. of John J. Bankston, Pike County, Miss., who md. Ferriday Carter, one of the forced heirs of Samuel Carter and Charity Carter. Represents that Samuel Carter died in Nov., 1837 in Pike County, Miss., leaving property in St. Helena: a tract on the NE part of the parish, bounded E by Tangipahoa River, N by state line, S and W by lines so as to include a section of land. Land was sold to Pharoah Carter. Charity Carter, the widow of Samuel Carter still resides in Pike County, Miss., and that the other heirs are: William P. Carter of St. Helena, Daniel Carter of New Orleans, Pharoah Carter of Kingston, Adams County, Miss., James Carter, Charity Carter, Ferriday Carter wife of petitioner, <u>Elizabeth Carter wife of Jesse Redman</u>, and all of Pike County, Miss.

Henry Carter was administrator; Charity Carter received \$903.25; each of the other 8 heirs \$112.90 each.

WALTON N. CARTER, 1852 File C-1

Sept. 2, 1852 - Pet. of Burrell Carter shows that his son Walton N. Carter died Apr., 1852, leaving no children. Surviving are his father, mother, brothers and sisters.

Nov. 12, 1852 - Family meeting: Dr. A. B. Taylor, Marcus T. Carter, relatives, and John Corkern, Amos Kent and Harrison B. McKie, friends. Inventory on Nov. 18, \$1662.50

MRS. NANCY CARTER, Ner Tate, 1853 (Wife of Henry Carter) File C-1 Aug. 23, 1853 - Family meeting: James Tate, Harvey Tate Sr., Lafayette

Tate and John Westmoreland, Jesse Westmoreland, William Westmoreland, and George Westmoreland. Meeting in regard to the minor heirs of decd. Sept. 2, 1853 - Meeting advised that tract of land of Nancy Tate be sold.

ELIZABETH CARROLL, 1849 (Wife of Anderson Carroll) File C-1

Oct. 6, 1849 - William Travis states that Mrs. Elizabeth Carroll died recently in this parish leaving two minor children: Henry Carroll and Amanda V. Carroll. There is left no person to take charge of the property other than petitioner, who is one of the nearest neighbors and a distant relative.

Oct. 16, 1849 - Family meeting: John Carroll, John Smith, William Lea, James Bellue, William Travis, Jackson Catha. John E. Smith is named tutor and John Carroll, under-tutor. Land to be left in charge of the tutor. Nov. 19, 1849 - Sale of personal property. Purchasers: E. D. Waller,

Nov. 19, 1849 - Sale of personal property. Purchasers: E. D. Waller, Mrs. Edier, Cannon Travis, John Harris, Elbert Haley, William Lea, Henry Carroll, John McPherson, Reuben Lee, Thomas Phillips, E. B. Draughon, Thomas A. Roddy, William Travis, <u>Henry Newsom</u>, John Smith, Richard Austin, Ebenezer McNabb. Total \$323.23

Deceased was the wife of Anderson Carroll deceased.

JAMES CARRUTH, 1844 File C-1

Sept. 4, 1844 - Mrs. Francis L. Carruth, nee McLain, appointed natural tutrix of Ansel Allen Carruth, minor son of her husband James J. Carruth. Daniel Newton is appointed under-tutor. John Holloway appointed executor of the Last Will and Testament same date.

Sept. 4, 1844 - Will dated Aug. 20, 1844. He requests that Parker McLain of Amite County, Miss., be his executor and that John Holloway be the same in La. He requests that his property be carried to his plantation in Amite County, Miss.; that his wife Francis L. Carruth and his son Ancell Allen Carruth go and live with said Parker McLain; that his mother Susan Carruth be allowed to keep the wagon now in her possession.

Sept. 9, 1844 - Inv: Lot in Greensburg, being last residence of decd; also the next half of the adjoining lot. The first lot is No. 22 and the other half No. 21 fronting the public square, 90 ft. and running back 120 ft. \$500 Plus slaves, cattle, etc. Total Estate \$7547.47

July 14, 1845 - John Holloway files his account.

Aug. 1, 1845 - The widow, Mrs. Francis L. Carruth, objects to every claim submitted by John Holloway, executor. John Holloway is also the adm. of the succession of James R. Goff, decd.

Aug. 4, 1848 - Dr. W. P. Dean states that James J. Carruth promises to pay an account of William Cole against the succession of Elisa Hoff.

Dec. 22, 1845 - Pet. of Francis L. Benton, wife of Josiah Benton of E. Feliciana Parish, represents that her former husband, James J. Carruth, died in St. Helena Parish leaving one child Ancel A. Carruth. Family meeting on Jan. 3, 1846: Jesse L. Carruth, Reuben Carruth, John Carruth, Walter Carruth, and Renny Lee.

Mar. 23, 1846 - Greensburg lots sold to Isaac H. Wright for \$350. (He resided on the property at the time.)

WILLIAM AND SUSANNAH CARRUTH, 1848 File C-1

May 11, 1846 - Inventory of Mrs. Susannah Carruth decd. Total \$3146. Oct. 9, 1846 - Family meeting: Jesse L. Carruth is recommended as WILLIAM DAVIS, 1850 File D-1

May 16, 1849 - William Davis bought from Wm. P. Dean the 1/2 of Lot No. 40, Greensburg, being the W 1/2 of the lot, bounded N by Lot 39, S by Lot 52, E by the E half of Lot 40, W by numbers 34, 35, and 38, being the same lot on which there is a blacksmith shop built by sd. Davis.

.... Mrs. Elizabeth Davis, the widow, states that Ashferd Addison has taken it upon himself to be admr. and has taken into his possession a set of blacksmith tools belonging to her. She and William Pepper oppose sale until after hearing.

Oct. 26, 1850 - Mrs. Elizabeth Davis represents that her husband William Davis died Aug. 21, 1850, in E. Feliciana Parish. She is appointed admr.

Nov. 30, 1850 - Inv. total \$188.00. Sale on Feb. 1, 1851: Wm. Pepper purchased the blacksmith shop and tools.

JOHN DAVIS, 1853 File D-3

Apr. 4, 1853 - W. W. Pilkinton represents that Margaret Penelope Davis is a minor child of one of his decd sisters, Martha Davis decd; that the father John Davis is also decd. Margaret's stepmother is living and mother of the co-heir. Pet. is an uncle of sd. Margaret. (All)

THOMAS W. DAY, 1834 File D-4

Oct. 3, 1834 - William Carruth, John Day, Cade D. Strickland, Harvey Day, and John Burton cited to attend family meeting.

Oct. 9, 1834 - Mrs. Nancy R. Strickland represents that her husband Thomas W. Day died lately leaving two minors, William Day and Dicy Day. Pet. is natural tutrix; William Day is grandfather of the minors and under-tutor.

Oct. 9, 1834 - Inv: 640 acres being last residence of decd, half being purchased in 183_ valued at \$500 and the other half purchased in 183_ valued at \$500; plus slaves, horses, etc. Total estate \$3020.

Nancy R. Day, the surviving widow of Thomas W. Day, opposes the application of Harvey Day for Administration.

Nov. 7, 1834 - Sale of personal property to: <u>James Newsom</u>, Uriah Youngblood, Hiram Crittendon, Nathaniel Amacker, Harvey Day, Simpson Hutchinson, John Burton, Pearson Wells, Thomas Reddy, Ephraim Bates, David Hunter, Nancy Day, Jacob Womack, R. Hazard, Wm. Day, Druery W. Wall, Wm. S. Gordon.

Dec. 20, 1836 - Supplementary inv: 320 acres bounded N by succession lands, W by Tickfaw River, N by John Burton, E by vacant lands - \$1200; 320 acres bounded on the above tract - \$800. Sale on Dec. 20, 1836: One tract purchased by William Day and the other by Mark A. Gillispie.

Dec. 22, 1836 - Mrs. Nancy R. Strickland, alias Gillispie, files account as the former wife of Thomas Day decd. Since the death of her husband, two of her children have died leaving her sole heir; she has since married Mark A. Gillispie. She wants partition between her and sd. heir William Day.

Oct. 23, 1838 - William Day Sr. pet. for letters of admr. on the succession of his grandson William Day Jr.

Oct. 12, 1843 - Wm. Day Sr. Vs Mark A. Gillispie et als; partition ordered. Oct. 16, 1843 - Cade D. Stricklandcited to be present at the partition of land belonging to the succession of Thomas W. Day decd in his capacity as tutor ad hoc to the minor children of Mrs. Nancy Gillispie, late of Miss., decd.

Oct. 20, 1843 - Inv. of tract of land belonging to Thomas Day decd. Advertised to be sold Aug. 19, 1844.

(This found among the appers in this succession, but may be part of Allen succession) - Harvey Day, Elizabeth Day wife of William S. Gordon, William Allen, Elizabeth Allen wife of Jesse Carruth, Thomas Allen, Sarah Ann Allen wife of

William Bates - interested in the land in the following proportion: being 1/3 of the ld. to Harvey Day, 1/3 to Elizabeth Day wife of Wm. Gordon, 1/3 to Elizabeth Allen, Thomas Allen, and Sarah Ann Allen.

WILLIAM DAY JR., 1838 (Son of Thomas W. Day) File D-4

Oct. 20, 1838 - William Day Sr. represents that Wm. Day Jr., a minor living with his mother in Mississippi, died in the fall of 1837 or 1838, leaving in this parish considerable property, mostly notes, as shown on the partition between Mrs. Nancy R. Strickland Day Gillispie, the surviving widow of his father Thos. W. Day.

Oct. 23, 1838 - Wm. Day Sr., grandfather of Wm. Day Jr., is appointed admr. Nov. 5, 1838 - Inv: Amount due from the partition of the succession of his father Thos. W. Day decd - \$3964.83.

Feb. 10, 1846 - Mrs. Nancy Pearson, wife of Harvey Day decd, represents that her husband died in Oct. last (1845) and left 6 children lawful heirs of whom she is the mother.

Mar. 9, 1846 - Mrs. Nancy Pearson widow of decd appointed administrator. Inv. on Feb. 24 showed: 640 acres on which decd lived, bounded N by William Day, E by Tickfaw River, S by L. H. Venable, W by vacant land - \$1800. (separate property). Community property - 640 acres on Sandy Run bounded N, W, and S by vacant land, W by Thomas H. Reddy - \$880; 180 acres on Beaver Creek bounded N by vancant lands, E by Elijah Lambert, W by Nancy Morrow, S by public land, being the undivided 1/2 of 360 acres - \$200; 320 acres on Pinke Branch bounded on all sides by vacant land - \$440; 1 town lot in Greensburg bounded N by lot owned by Pearson and Tate, E by public square, W by D. Newton, S by Middleton -\$80; slaves, horses, etc. Total estate \$13,390.

Dec. 13, 1847 - To William Day Jr., William Allen, W. G. Bates, Jesse L. Carruth, and Henry Melton, etc., relatives and friends of said minors: Lydia Day wife of James A. Thompson, one of the heirs of Harvey Day.

Mrs. Nancy Pearson, widow of Harvey Day, marries Thomas H. Roddy.

Dec. 14, 1847 - Nancy Pearson, widow of Harvey Day decd, shows that she is natural tutrix of minors: Demarcus D Day, Martin P. Day, William Day, and Thomas D. Day.

Jan. 7, 1851 - Mrs. Nancy Roddy purchased the Sandy Run tract. Partition between: Lydia Day wife of Wm. F. Venable, Demarcus D. Day, Martin P. Day, Dicy Day wife of Renny Lee Jr., William Day, and Thomas G. Day as forced heirs of Harvey Day decd. Thomas D. Allen is special tutor for Thomas G. Day.

THOMAS and ANN DAY, 1848 File D-1

Dec. 11, 1848 - Elizabeth Day, wife of William Melton, shows that Thomas Day died years ago leaving land in community with his late widow Ann Day. Ann Day died during 1844 leaving the said land, bounded N by William S. Gordon, E by John Day, S by heirs of John Bates. Thomas and Ann Day left children: John Day, Henry Day, William Day Jr., Drucilla Day wife of Henry Melton, Ann Day wife of (Widow of) John Rainer decd, Dicy Day widow of James Martin decd, Emiley Day. wife of Thomas Phillips, Isabell Day, Sarah Day wife of James Anderson, Rapides Parish, and petitioner Elizabeth Day wife of William Melton. All are of age.

Cade D. Strickland represents that he is the owner of the interest of John Anderson and his wife Sarah Day as per Book F, page 218.

The heirs agree to a sale of the land.

Nov. 1, 1850 - Cade D. Strickland sells his interest to William Lindsey. Augustus Jennings buys the interest of Henry Day. Dec. 12, 1850 - Heirs own tract on E side of Tickfaw River bounded on W by sd. river, containing 632 acres and known as the Thomas Day tract. Isabel Day owns her own interest and that of John Day.

Drucilla Melton, Ann Rainer, and Elizabeth Melton, being $4\frac{1}{2}$ shares. Drucilla share is only a 1/2 share; Dicy Martin owns her own share and that of Sarah Anderson by purchase from William Lindsey. Augustus Jennings owns the share of Henry Day, which is 1/2 share. Emily Phillips owns her own share and William Day, his. The land is to be divided into 9 equal lots.

WILLIAM DAY, 1851 (Son of Thomas & Ann Day) File D-4

Sept. 20, 1851 - M<u>rs. Eliza Redman, surviving widow of William D</u>ay decd, represents that her husband recently died leaving 6 children: Drucilla Day wife of Hickerson Ripley Barksdale, and minors - Thomas Warren Day, William Alexander Day, Laura Ann Day, Letha Ann Day, John Henry Day. She is appointed natural tutrix with Thomas W. Day under tutor.

Oct. 8, 1851 - Inv: 71 acres being his mother's land appraised at \$60; 352 acres being the homestead tract appraised at \$500 (separate lands); community lands: 91 acres last residence of decd appraised at \$300; plus slaves, horses, etc. Total estate \$3866.

Dec. 18, 1851 - Pet. for partition. Statement of heirs as above. Mrs. Eliza Day, widow, shows that since the death of her husband she has had another child, Mary Ann Kansade.

Sept. 27, 1852 - Family meeting: John Day, Henry Day, Thomas Day, Jesse Rainer, Thomas D. Rainer. Notice was served on Cade D. Strickland Jr. by handing it to Mrs. Manerva Strickland, his wife.

Sept. 29, 1852 - Sale of 71 acres to John Bridges signed by Eliza Hays and Parker Hays. (From this it would seem that the widow Eliza Redman Day married Parker Hays.)

Mar. 15, 1853 - Partition between Eliza Redmon, now the wife of Parker Hays, and the children of decd, towit: Drucilla Day wife of Hickerson Barksdale, Thomas Warren, William A., Laura Ann, Leathy Ann, John Henry, and Mary Ann Canadda Day.

WILLIAM and DICY DAY, 1852 File D-4

Apr. 27, 1852 - Lydia Holden, widow of William Day decd and former widow of Harvey Pearson decd, represents that her husband William Day died heaving heirs, property, etc.

May 26, 1852 - William S. Gordon and William S. Bates appointed admr. They represent that their wives are heirs of William Day who died Apr. 22, 1852. Wm. S. Gordon is husband of Elizabeth Day, dau. of decd. The decd had two other heirs: Harvey Day now decd, whose children are Lydia Day wife of William Venable, Demarcus D. Day, Martin, William, Dicy, and Thomas Day, all represented by their mother Mrs. Nancy Roddy; and Nancy Day decd, a dau. of decd who married John Allen. His children are William Allen, Thomas D. Allen, Elizabeth Allen wife of Jesse L. Carruth, Nancy Allen wife of Petitioner Wm. S. Bates, and being grandchildren of William Day decd.

Nancy, Elizabeth, and Harvey are children of Wm. Day by his 1st wife Dicy Cross. Above named children and grandchildren are the only heirs of Wm. and Dicy Day. The widow Lydia Holden is separated in property and community from sd. decd and is old and unable to attend to the business of the estate. Admr. necessary.

Apr. 27, 1852 - Inv: 580 arpents on E side of Tickfaw River bounded N by the Allen tract, E by Bazoon, S by William Venable, W by Tickfaw River, known as the Jackson tract; 640 acres on E side of Tickfaw known as the John Allen tract bounded N by the Hoff tract, E by unknown, S by the Jackson tract, W by Tickfaw ₩ Ьу

Oct. 28, 1852 - Partition ordered of all property acquired by William Day decd prior to Mar. 3, 1842.

Jan. 27, 1853 - Partition, heirs notified: Elizabeth Day wife of William S. Gordon, Harvey Day decd, Nancy Roddy, her children as follows: Demarcus D. Day, Lydia P. Day wife of Wm. F. Venable, William Allen, Thomas D. Allen, Elizabeth Allen wife of Jesse L. Carruth, Sarah Ann Allen wife of Wm. S. Bates.

There being only three heirs to the estate by roots viz: Elizabeth Gordon, the heirs of Nancy Allen decd wife of John Allen, the heirs of Harvey Day. Nancy Roddy tutrix for Harvey Day heirs.

Dec. 31, 1852 - Land sold to William Allen, Reuben Lee and W. K. Carruth, Lydia Day wife of Wm. F. Venable, Mrs. Nancy Roddy.

Dec. 28, 1853 - The widow Lydia Holden Day has now married _____(Feb., 1854) Jan. 3, 1855 - Sales to Thaddus C. S. Robertson, Wm. S. Gordon, John J. Bridges, Thomas D. Rainer, H..W. Strickland, Jesse L. Carruth.

WILLIAM P. DEAN, 1852 File D-1

Oct. 19, 1852 - Pet. of Eliza Veirs, wife of William F. Womack, formerly the wife of William P. Dean decd, who died in St. Helena Parish leaving pet. his surviving widow and the following children: Albert Dean, Elizabeth Dean, and Emily Dean all minors. Nathaniel Amacker is tutor. Of the heirs the pet. is the mother.

Dec. 22, 1852 - Family meeting recommends sale of land and slaves. Mar. 15, 1853 - Final account of Mrs. Elizabeth Womack, formerly Mrs. Eliza Dean tutrix. Total \$11,383.35.

DIEGO DEAS, 1817 File D-1

Pet. of John Deas, curator of person and property of Antonio Sepprian Deas, minor son of Diego Deas, decd - that sd. Antonio S. Deas, minor, is deprived of the use of his limbs, that there remains of the estate of Diego Deas an undivided tr. of land in district of Galvestown, parish of St. Helena, 250
