p. 178 MIMY HOLIFIELD of Wake Co. deed of gift to her loving daughter, MIMY KILGO, of Wake Co., June 8, 1799, for love and affection all of her goods and chattels now in her possession. Wit: JOSEPH HOLIFIELD, JAMES KILGO.

p. 178 DANIEL TUCKER of Wake Co. to JAMES AVERY of same, Nov. 15, 1797, for 202 silver dollars a tract of 204 acres on the waters of Little Lick Creek beginning near a road at WILLIAM FERRELL's line and adjoining JOHN NICHOLS, BURNS, and PITCHFORD, excepting two acres, one including the meeting house and the other opposite his mill. Wit: RICH'D C. PATTISHALL, WILLIAM HODGES, JOHN HODGES.

p. 180 ISAAC HICKS of Wake Co. to WILLIAM MARTIN, JUNR. of same, March 27, 1799, for 350 dollars a tract of 27 acres on the east bank of Richland Creek adjoining ALSEY HIGH. Wit: EDWIN HOLDING, JAS. HARRIS.

p. 181 ZACHARIAH THOMPSON of Wake Co. to his son, SOLOMON THOMPSON, of same, May 13, 1799, for 100 pds. N. C. currency a tract of 162 acres on the bank of Richland Creek adjoining FREDERIC HOLDING. Wit: JOS. HOLDING, BENJ. THOMPSON, JONATHAN THOMPSON.

p. 182 JAMES CRENSHAW of Wake Co. to DAVID FOWLER of same, March 1, 1798, for 50 pds. specie a tract of 50 acres on the north bank of Horse Creek and on a small creek adjoining RIVERS, LOWRIE, and ALLEN. Wit: ROBT. CRENSHAW, ELIZABETH CRENSHAW.

p. 183 JOHN HUSKEY of Wake Co. to WILLIAM SHIP of same, Jan. 19, 1798, for 640 dollars a tract of 320 acres on the north bank of Nuce River adjoining CLARK, PACE, and AARON REED PENDRY, it being parts of two tracts of land granted to PHILLIP JONES and JOHN MARR. Wit: JNO. HUMPHRIES, STEPHEN GILL.

p. 184 WILLIAM MARTIN, SENR. of Wake Co. deed of gift to his son, WILLIAM MARTIN, JUNR., Oct. 25, 1798, for divers good causes and considerations his negro fellow, BARN, the blacksmith, and his negro fellow, BEN, the striker, together with smiths' tools. He reserved the use of negro BARN and the smiths' tools for the natural lives of both he and his wife, ANNEY MART-

and the County line adjoining RICHARDSON's former corner, it being a tract of land granted to the State to said BOHANNON. Wit: ABEL OLIVE, FIELD.

p. 401 ISAAC HUNTER, SENR. of Wake Co. to JOHN MILLER of same, Nov. 13, 1798, for 294 dollars a tract of 147 acres on the south side of Nuce River adjoining WILLIAM OLIVE, it being the land whereon JOHN SINGLETON formerly lived and is part of a tract of 287 acres formerly granted to JOSEPH EMBROUGH from the State of N. C. Wit: NATH'L LANE, ISAAC HUTCHINS.

p. 402 WILLIAM LOVE of Wake Co. to SAMUEL RABOTEAU of same, Jan. 22, 1800, for 400 silver dollars part of a certain lot in the City of Raleigh on Fayette Street and Salisbury Street, 30 x 210 ft. Wit: E. PRIDE, CHARLES PARISH.

p. 403 JONATHAN THOMPSON and PHARABY THOMPSON of Wake Co. to JESSE MOBLEY of same, Aug. 16, 1800, for 32 1/8 current money part of a tract of land containing 38 1/2 acres lying on the east side of Mobleys Branch adjoining JESSEE MOBLEY and ALLEN MOBLEY. Wit: SAMUEL MASSEY, PETER VINSON, ALLEN MOBLEY.

p. 404 JOHN HUSKEY of Wake Co. to WILLIAM JONES of the other part, Nov. 19, 1797, for 57 pds. 10 sh. a tract of 100 acres in Wake Co. lying on the north side of Nuce River and on the bank of Island Creek adjoining JOHN MAR, WM. TATE, said JONES, and OBEDIAH F. ELLEN. Wit: JOHN JONES, BENJAMIN CLARK, LEWIS JONES.

p. 405 MATTHEW MACKLIN of Wake Co. to BENSON CARD of same, Sept. 24, 1799, for 110 pds. current money one Lot #173 in the City of Raleigh bounded by Newbern, Morgan, and Person Streets. Wit: JOHN HUMPHRIES.

p. 406 Virginia JOHN HUMPHRIES, JUNR. of Wake Co. to MATTHEW MACKLIN of same, planter, March 20, 1797, for 18 pds. current money the west half of Lot #173 in the City of Raleigh, bounded by Newbern, Morgan, and Person Streets, and by said MACKLIN on the east side. Wit: ROBERT JEFFREIS, MAT. McCULLERS, WILLIE FERRELL.

p. 407 JOHN HUMPHRIES (Vir.) of Wake Co. to SAMUEL REAVES of same, March 6, 1800, for 150 silver dollars a tract of 150 acres on the waters of Lick Creek adjoining BELVIN's old line, it being a tract granted
