stead of Elizabeth the present Guardian, and that the Guardian Bonds of the said
Elizabeth now filed in this Court, be recinded; that William WALTON enter into bond
in the sum of Three Thousand Pounds with Alexander MYATT, & Saml. WALTON Securities.
