Note:

The earliest known record of the Heard's in PA was of Charles' brother Stephen as a witness to a will of John Cohlan in Sadsbury, Lancaster Co. on 3 April 1727. There is no documented evidence of Charles in PA in 1720's and 30's however it is reasonable to assume his residence there due to records of his son Stephen (Jr.)'s marriage in 1736 to Mary Falkner, daughter of Thomas Falkner. The Falkner's lived near Charles brother's Stephen Heard's tract in Sadsbury.

Charles moved to Albemarle Co., VA in about 1744 receiving a land grant of 225 acres on 30 August 1744 on the South Hardware River. Albemarle Co. is on the eastern slopes of the Blue Ridge Mountains. On 4 August 1746 Charles signed a promissary note to Henry Clay. From this record we know that he was a blacksmith and that he could write.

Charles died sometime before July 1748. His will bequeathed his 225 acres to son Charles Jr. From court records we know that Henry Clay's note had not been paid. Charles Jr. and his wife Isabella had deeded the 225 acres to Charles' other son John in an apparent attempt to forestall the legal claims of Henry Clay. In May 1749 the

Albemarle Co. court ordered the sheriff to sell an iron fork and iron ring for repayment of debt and court costs.
