Record-Based History of the Family of Stephen Heard of Albermarle and Pittsylvania/Henry Counties, Va." compiled by Jayce Poole. 4 April 1997 the following statement on page 29: 1795

Wilkes-Ga. Deed.Bk NN, p194. Charles Heard relinquishes all claim to 200 acres in Wilkes Co. on Fishing Cr, the said land he got by his wife Margaret Brady. (S-28, p143 note by JPP: Harold Heard on p18 of M-33: "There is ample documention from Wilkes Co., Ga. that Charles Heard of Wilkes Co. married Margaret Brady." The point he was making here was that there are two Charles Heards; one in South Carolina during the Revolutionary War was said by Silas Wright Heard to have married a "MISS LOGAN" (FIRST NAME NOT GIVEN) and another Charles Heard who died in Wilkes Co.in 1797 who married 2nd Margaret Brady.

Charles married Margaret Ferguson Brady(a widow) about 1785 in Wilkes County, Ga. This second wife, Margaret Ferguson Brady, has been documented.

*a deed from Wilkes County, GA., Deed Book NN, 1795 - 1796:

(Wilkes)

p. 194 Charles Heard of Wiles Co., do give my wife, Margaret Heard, & her heirs or assigns forever (that is after my death) all that tract where I now lived in Wilkes Co. on Fishing Creek waters, 217 acres of said tract formerly granted to Margaret Brady, now Margaret Heard, & 17 acres. I assign over all my right in the tract to my wife as it came

by her, after my death, 17 Feb. 1795. (signed) Charles Heard. Wit: Sanders Walker, Joseph Heard, John Ray, N.B. also what hogs is on the plantation belonging to me with a white back cow and calf & Bety Brady a heffer & calf, & a mare colt that is now out, & everything that came by said wife. I give to her forever, & corn on the plantation. Proved by John Ray, Sanders Walker, & Joseph Heard, 2 Nov. 1797, before Wm. Sansom, J.P. Regd. 30 Dec. 1795.

CHARLES HEARD ((CHARLES,STEPHEN)) was born Abt. 1701, and died September 21, 1795 in Wilkes County, Georgia. He married first Elizabeth sometimes called Isabella, and married (2) Mrs MARGARET Ferguson BRADY.

Notes for CHARLES HEARD: Will of Charles C. Heard - Wilkes County, Georgia was made August 25, 1792 and proved December 5, 1795.

GRANTEE Heard, Charles. grantee. DATE 30 August 1744. Location: Goochland County. Description: 225 acres on the branches of Hardware River adjoining Mildred Meriwether. Source: Land Office Patents No. 22, 1743-1745 (v.1 & 2 p.1-631), p. 202 (Reel 20). Part of the index to the recorded copies of patents for land issued by the Secretary of the Colony serving as the colonial Land Office. The collection is housed in the Archives at the Library of Virginia.
