Son of Wm Rountree, indexed. "I give and Bequeath to Richardson Rowntree all my land that lies on the other side of the creek commonly called the middle Creek and also on this side the Creek from mouth of a branch, etc Two hundred Acres be the Same more or less --also one Negro Boy named George to him and his heirs for Ever with Five head of Cattle some Grown & some Small. "I Give unto my son Thos Rowntree ....250 "Acres To him and his heirs for Ever be the Same more or less also one Negro Boy Named Charles, one feather bed & Firniture to him and his heirs for Ever... "I give and bequeath to my son Turner Rountree my manor Plantation with all the Residue of the said Traik....also one Negro Girl named Lucy and hur Increase....also one Feather Bed & Firniture one Coper still & one Coper Kittle--To him and his heirs for Ever." "I give & bequeath to my son Randall Rountree...one Negro Wench Named Nan with her Increase to him and his heirs for Ever. "I give & Bequeath to my Daughter Drusilla Haden....one neagro Boy named Ben to hur heirs for Ever & Thirty Geese "I give & Bequeathe to my Daughter Molley...one Neagro Wench named Phillip also one Sorrell mair & Colt a horse one best Feather Bedd and Firniture the sum of Thirty Rex Dollars---Currt Money and Thirty Geese and Double Loan... for hur kindness to me in my Sickness to her and hur heirs for Ever. "My Will and Desire is that my Negro Fellow named Ripp may be hired out from time to time During the Life of my Executors and the Profits of his hire to go to the use of my Daughter Isabell etc..... "My Will and Desire that all the Residue of my Estate may be sold & the money Arising be Equally Devided between the following children (viz0 Turner, Molley, Darcas, Drusilla and my Grandson John Bailey. The money that is Jno Bailey's

part to be paid to him .....at the Age of Twenty one yeares. "I give and bequeath Unto my Grand Daughter, Massie Goldsmith(and to Lewsey,, Eliza, Lewsender and Milley Goldsmith} fifteen shillings to be maid in a Ring & To be Delivered hur at the Age of Fifteen..... "I do hereby Constitute and Appoint my son William Rountree, Turner Rowntree Randall Rountree, & My Loving Friend Stoakes McCaul my whole & sole Executors of this my Last Will & Testament.....etc..... Willm Rowntree (Seal)

in "Estate of Richardson Rowntree" an entry on May 21st 1819 "Pd Cary Cox. Legacy \$725. Asa Cox inherited one Negro Woman named Nell and one Negro girl named Leak. Also: "Amt Sale Sold the 18th & 19th May 1819 9097 Due the Estate 7125.68"
