## Notes for John Bird I:

At one time he owned land on Gilkie (sic) and Thickety Creek in South Carolina. Note: You can locate this section by looking at the map in the front of the 1790 Census of South Carolina. There are two branches on the left side, so one of these must be Gilkie Creek.

John Bird I joined the El Bethel Baptist Church in 1804 by faith and Baptism, but sometime later he was "excommunicated." [Edmund Ellis and many of the Guytons also belonged to this church].

From General Services Administration record, File No. S-39196:

Enlisted from South Carolina in 1776 for 3 years and served in the Revolutionary War as a Private and Sergeant in the Sixth Regiment under Captain George Worley and Colonel Henderson, and later was transferred to the First South Carolina Regiment and served as a Lieutenant under Captain Turner and Charles C. Pinckney. He served both in the South Carolina militia and then with the South Carolina Continental Troops during the War. Name was spelled as "Burd" in the 1790 census of Union County (i.e., District(?)) South Carolina. Was a Captain in the South Carolina militia after the War.

His brother Wiliam served with him in the Revolutionary War and was captured with him May 1780 during the Siege of Charleston. They were both released soon released on July 1, 1780 from prison (in a general exchange of prisoners]. They were not in prison very long. He soon returned to the Army fought to the end of the War.

He was wounded both in the Siege of Savannah and the siege of Charleston.

The officers of his unit (all from Orangeburg District) were:

Colonel William Henderson - from Orangeburg District Colonel Charles C. Pinckney - from Charleston District Captain George Warley- from Orangeburg District Captain George Turner - from Orangeburg District

He applied for a pension July 7, 1818, and his residence was Union District, South Carolina, and he listed his property as 60 acres and household goods, all valued at \$150 by John Rogers, Clerk of Court. It was granted and paid in Union District, South Carolina. At the time he applied for the pension he gave his age as 56, then later n 1821 as 64 years.

Was reported to be blind several years before his death and was unable to travel.

In a statement before the Court of Ordinary in South Carolina his daughter Anna C. Smith appeared and stated that he had died and left the following children:

- 1. Anna C. Smith, age about 56 years, now a resident of Union District.
- 2. Sally Bird, now the widow of James Carr (Kerr), age about 60 years, when last heard from was living in Mississippi.
- 3. Henry C. Bird, age about 54 years, not heard from for many years, but last in Texas.
- 4. Catherine Bird, age about 51 years, now Mrs. Faucett, last heard from in Alabama.
- 5. James C. Bird, age about 46 years, last heard from in the state of Alabama
- 6. John Bird, Jr. died many years before his father, left 5 children, was residing somewhere in the Far West.

According to a deposition by Nancy (Bird) Clarke, Union District, 30 June 1853, her father, John Bird, Jr, died in 1828-29, and that she was one of four sisters still living.

He married Mary (Polly) Guyton Abt. 1822, daughter of Abraham Guyton and Martha Ellis. She was born 09 May 1800 in Union District (now Cherokee County), SC, and died Bet. 1840 - 1850 in Arkansas?.

### Notes for James Calvin Bird:

[Ruth Ann Kerr of Texas sent some information to Viola F. (Mrs. R. B.) Hamner, 11415 Riveria Court, Sunnymeade (or Sunny Meade), CA 92388. According to Ms. Kerr, James Calvin Bird was married to Mary (Polly) Guyton. This was the only Bird family near the Guytons, and others intermarried: Guyton-Bird-Smith was common then. This James Calvin Bird had an older brother (Henry C. Bird) who first married in Union District, South Carolina, and had a daughter, but wife and child died between 1820-1830 in Union District. The brother (Henry C. Bird) it is said came to Arkansas in 1830 and settled in Scott County.]

He was reported to be in Tuscaloosa County, Alabama, in 1840. It is supposed that he died before 1840 in Alabama and his wife and most of his children went to Arkansas [the 1840 census for Pickens County, Alabama, shows "Mary Bird, widow".] However, another source suggests that he left for Arkansas by himself just before 1840 and died there. He MAY have gone to join is brother, Henry C. Bird, in Arkansas and never returned to Alabama.

### Notes for Marion Evelyn Bird:

Marion Evelyn Bird

[His middle name was pronounced "Eve' lynn" and apparently is an old Bird/Byrd family name. Admiral Richard Evelyn Byrd, the famous explorer, had the same middle name]

His father must have died when Marion was very young and sometime after the birth of his sister (and last sibling), Saphronia, in 1838. Sometime between the birth of Marion's sister Amanda in 1829 and Marion in 1837, his Father, Mother and six brothers and sisters moved from South Carolina to a plantation near the town of Reform in Pickens County, Alabama, close to the home of her brother, Whitaker W. Guyton. When Marion's father died, his uncle (his mother's brother), took the family in near the town of Reform at a "village" that is now named McShann. They lived on the 455 acres known as "the Guyton Old Place," later known as "the Bird Home," indicating that Mary (Polly) [Guyton] Bird either bought or inherited the property from her brother, Whitaker Guyton. The home is still in McShann, in Pickens County, Alabama.

[Note: In the 1930's the McShann's, still in Alabama, wanted to buy the "ol' Bird house." Because of the

Civil War and the deaths of A.G. and Marion, there was a great deal of difficulty in obtaining clear title to the land. A.G.'s son, John Whittaker Bird, had the chore in the 1930's of obtaining signatures from all of A.G.'s descendants to finally clear the title and sell the place to the McShann family. The McShann's now mistakenly refer to the place as the "Baird" place, probably because the elderly black people (then called "darkies"), in their 19th century "Alabama plantation" pronunciation, vocalized the name "Bird" as "Baird."] Marion Bird was born in Pickens County, Alabama in 1837. He was shown n trhe 1850 census as living with his Uncle, Whitaker W. Guyton.

Marion's Father and Mother must have moved from the area of Union District, South Carolina, to what is now the hamlet of McShann, in Pickens County, Alabama, before Marion was born. Marion's father died when Marion was a little boy; his Mother remarried(?), and he was raised in the house his father had built near the town of Reform, in Pickens County, Alabama, by a Mr. McShann and they occupied the house built by his father.

[Note: In the 1930's the McShann's, still in Alabama, wanted to buy the "ol' Bird house." Because of the Civil War and the death of A.G. and Marion, there was a great deal of difficulty in obtaining clear title to the land. A.G.'s son, John Whittaker Bird, then living in Magnolia, Arkansas, had the chore in the 1930's of obtaining signatures from all of A.G.'s descendants to finally clear the title and sell the place to the McShann's. The McShann's mistakenly now refer to the place as the "Baird" place, probably because the elderly black people (then called "darkies"), in their 19th century "Alabama plantation" pronunciation, vocalized the name "Bird" as "Baird."]

Marion, A.G. and \_\_\_\_\_ Dees returned to Columbia County where A. G. married Martha (Mattie?) Dees, but Marion never married.

In about 1861 Marion and A.G. both joined the Confederacy. Marion joined the 6th Arkansas and was wounded at the Battle of Shiloh. He recovered from his wounds, went to Pickens County, Alabama, and then returned to Columbia County, Arkansas where he joined Company A of the 33rd Arkansas Infantry (Brigadier General (Brevet) Grinsted's Regiment) as a Private, and went to Camp White Sulphur Springs, Arkansas. Marion, then promoted to Corporal, was the flagbearer for Brigadier General Grinsted, the Confederate Brigade Commander at Jenkins Ferry. As the battle began, Marion and the General rode together toward the front of the line and were both knocked from their horses by the first volley of a Yankee cannon. Marion, knowing full well the dangers faced by riding his horse while carrying the Confederate flag, nonetheless remounted with the CSA flag and rode forward. He was soon felled by a rifle bullet and died on the field of battle. He was killed in the battle of Jenkins Ferry on April 30, 1864

Abraham Guyton<sup>5</sup> Bird (James Calvin<sup>4</sup>, Elizabeth<sup>3</sup> Fawcett, Nancy<sup>2</sup> Whitlock, William<sup>1</sup>) was born 22 Mar 1823 in Union District, SC, and died 11 Aug 1864 in Yankee Prison Camp, Rock Island, Illinois. He married Martha Dees 26 Nov 1857 in Columbia County, Arkansas, daughter of Daniel Dees and Mary Burt. She was born 09 Oct 1833 in probably Talledega County, Alabama, and died 06 Mar 1911 in Columbia County, Arkansas.

Notes for Abraham Guyton Bird:

Abraham Guyton (A.G.) Bird was born in Union County (District), South Carolina March 22, 1823. His father's name was James Calvin Bird and his mother was Mary (Polly) Guyton. His father must have died when A.G. was young and sometime after the birth of his sister (and last sibling), Saphronia, in 1838. Between the birth of A.G.'s sister Amanda in 1829 and Marion in 1837, his Father, Mother and six brothers and sisters moved from South Carolina to a plantation near the town of Reform in Pickens County, Alabama, close to the home of her brother, Whitaker W. Guyton. When A.G.'s father died, his uncle (his mother's brother), took the family in near the town of Reform at a "village" that is now named McShann. They lived on the 455 acres known as "the Guyton Old Place," later known as "the Bird Home," indicating that Mary (Polly) [Guyton] Bird either bought or inherited the property from her brother, Whitaker Guyton. The home is still in McShann in Pickens County, Alabama.

[Note: In the 1930's the McShann's, still in Alabama, wanted to buy the "ol' Bird house." Because of the Civil War and the death of A.G. and Marion (his brother), there was a great deal of difficulty in obtaining clear title to the land. A.G.'s son, John Whittaker Bird, a lawyer in Magnolia, Columbia County, Arkansas, accepted the task in the 1930's of obtaining signatures from all of A.G.'s descendants to finally clear the title and sell the place to the McShann family. The McShann's now mistakenly refer to the place as the "Baird" place, probably because the elderly black people (then called "darkies"), in their 19th century "Alabama plantation" pronunciation, vocalized the name "Bird" as "Baird."]

In about 1849 A.G. left Pickens County, Alabama, to go to the California Gold Rush. But instead of going directly to California, he first traveled to Washington, Arkansas, and found land, and later settled near Magnolia, Columbia County, Arkansas. He went to California by first to going to New Orleans and traveling to California by Clipper Ship around South America. He stayed about one year and returned to Arkansas after finding no gold.

In about 1852 he went BACK to California with his future Brother-in-Law, Daniel Dees (who had married a Creek Indian). They somehow got to the east coast of Panama and crossed the Isthmus of Panama, then caught a steamer to California. He spent time at a place called Texas Tower in El Dorado County, California, and sent a letter back home on July 28, 1853 when he was at Weber Creek Flat in El Dorado County. He was there when the Post Office burned in Sacramento, a fact he stated in a letter home. His brother Marion, who had been working for Mr. Rufus Archer, a merchant at a Mercantile Store in Magnolia, Arkansas, left his job and traveled overland by stagecoach and buckboard and joined him in the gold fields.

For all A. G.'s efforts, he found only one gold nugget of any size. He and Marion and \_\_\_\_\_\_ Dees returned to Columbia County where, on July 28, 1858 A. G. married Martha (Mattie) Dees who lived near the village of Calhoun east of Magnolia. Martha was the daughter of Daniel Dees and \_\_\_\_\_\_'s sister. A. G. and Mattie settled down near Calhoun and had two children, John Whitaker Bird and \_\_\_\_\_. A. G. was a constable in Columbia County in 1860.

On 29 March 1861 A.G. was mustered into Captain Austin's Company, Columbia Guards, and was appointed a 5th Sergeant in the 6th Arkansas Infanty Regiment of the Confederate Army. Sometime in 1863 A.G. was released from the Confederate Army to return home and "make a crop." After returning to Columbia County and doing that, he rejoined the Confederate Army as a Private in Company K of the 1st Arkansas Cavalary Regiment where he fought in the Battle of Jenkins Ferry just north of Camden, Arkansas, with his younger brother, Marion. He was captured on March 29, 1864 at Poison Springs in Clark County, Arkansas (at the Battle of Jenkins Ferry?) and sent to the Yankee prison camp at Little Rock, Arkansas, on May 3, 1864. He was "released" on on June 23, 1864 for transfer to the prison camp at Rock Island, Illinois, where he arrived on July 6, 1864. When he was captured, he told them his first name was (variously) Alonzo or Alex, because he didn't want them to think he had
