Zebulon BRINSON (son of *John BRINSON* and *Hannah STOUT*)⁷¹ was born Abt. 1750 in Hopewell, Hunterdon Co., NJ, and died 1804 in Montgomery Co, KY^{72, 73}. He married **Mary Ann RIBLIN** on Abt. 1768 in Virginia⁷³.

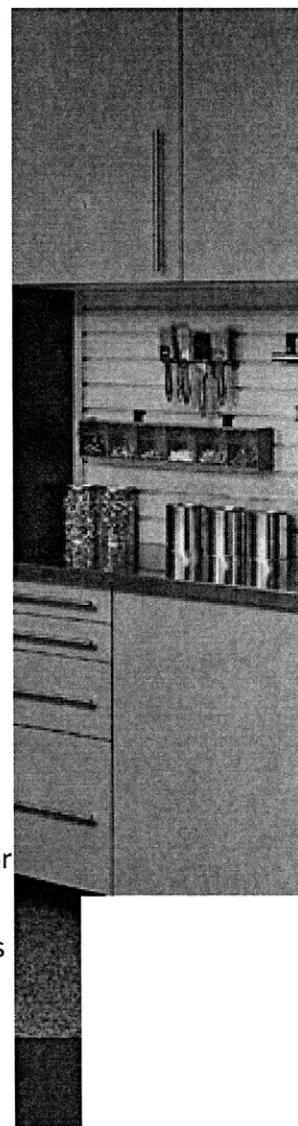

This is the oldest Zebulon BRINSON (born approximately 1750 in New Jersey), the brother of Stout BRINSON, just to get you situated. He was in Pittsylvania Co, Virginia, for a few years around 1780, before heading on to Kentucky. Note the BRIMSON spelling in the deed below. Though the really intriguing thing is that Zebulon BRINSON, in 1782, was appointed the administrator of the estate of Richard ELDRIDGE. Who was Richard ELDRIDGE? Zeb's father-in-law? Brother-in-law? I did most of this research during a brief visit to the Virginia State Archives a few years ago, and wasn't able to follow up...

Deed Book 4, page 181.30 Mar 1776 from Thomas JUSTICE of Camden Parish in Pittsylvania, to John WATSON Jr. of same, for 10 pounds, all that tract of land in Camden Parish and Pittsylvania on both sides of harping Cr, containing about 100 acres conveyed to the said Thomas JUSTICE by Ezra JUSTICE by Pittsylvania deed date June 11, 1773, and bounded by patent lines, Simeon JUSTICE. Signed - Thos JUSTICE.

Wit - Zebulon BRIMSON, William WATSON, Samuel (x) HUGHES, Thomas WATSON. Recorded Apr 25, 1776.



18 Mar 1782, Pittsylvania Co. Courthouse, Zebulon BRINSON filed a claim for one sheep provided during the war, 10 shillings.

Pittsylvania Co. Personal Property Tax Lists, 1782-1790, found Zebulon BRINSON only in 1783, listed as one male over 21, 3 horses, 5 cattle. (Only males over 21 were counted, so this doesn't mean he had no family.)

Deed Book 6, Page 3. 16 May 1780. Zebulon BRINSON of Pittsylvania to John WILLIAMS of the same, for 244 pounds, the tract on both sides of a Bold Branch of Mill Creek consisting of 244 acres granted to Zebulon BRINSON by patent. Next to George GRAY.

Witnesses - John BUCKLEY, John LUMPKIN, Jer. WHITE.

From the Land Office card file in the Virginia State Archives: To Zebulon BRINSON on 16 Nov 1779 in Pittsylvania Co., 244 acres on both sides of a Bold Branch of Mill Creek adjoining BYNAM, GRAY, etc. Book A, page 171.

Pittsylvania County Court Order Book 4. Page 185: William EASLEY -vs- Zebulon BRINSON, in trespass on the cave/case. Dismissed, defendant to recover costs. 26 Nov 1778. Page 201. Zebulon BRINSON received a license to run an Ordinary. William SHORT gave security for one year. 18 May 1779. Page 232. Daniel LOVELL -vs- Zebulon BRINSON, debt. Dismissed. 21 July 1779. Page 400. On the motion of Zebulon BRINSON and for reason appearing to the court, certificate is granted him for obtaining letters of Administration ... of Richard ELDRIDGE dec'd. Security posted by William DEVIN. William PIGG, Thomas PRICE, and John EMMERSON to appraise the estate. 21 May 1782.

These lists were taken from a typewritten copy found in the Clerk's Office, Pittsylvania County, at Chatham, Virginia. The two following affidavits found attached to the copy are self-explanatory.

I, S. H. F. Jones, do hereby certify that about the year 1930 I personally copied and had checked the names of persons who took the oath of Allegiance in 1777 as shown by manuscripts then in the Clerk's Office of Pittsylvania County, Virginia. The writing was faded and a few names could not be deciphered. Every effort was made to transcribe the names as they appeared on the manuscripts. The names of the foregoing Lists are a true and correct copy of the aforesaid manuscripts to the best of my knowledge and belief. The lists were also checked by Mr. Langhorne Jones, atty.

Given under my hand and seal this 8th day of November, 1939.

This Indenture made this ninth day of October one thousand eight hundred between Zabulon Brinson of Montgomery County and State of Kentucky and Samuel Welman of Maddison and State aforesaid Witnesseth that for Valueable Consideration to him the said Brinson in hand paid before the sealing and delivery of these presents the receipt whereof is hereby acknowledged in consequence whereof the said Brinson hath Given Granted bargained and sold and by these present doth give Grant bargain and sell unto the said Samuel Welman his heirs and assigns forever one tract or parcel of land Containing one hundred acres be the same more or Less lying and being in Madison County on the waters of Tates Creek and bounded as followeth (to wit) Beginning on

Thomas Potters line where he corners near Jones on John Masons line thence with said Potters line N25 E160 poles to where Potters corners on Ellots line thence with Ellots line S59 E fifty poles to Ellots Corner on a sugar tree on Green Clays line thence up the Creek with Green Clays line to where it Intersects with Bryants line thence with Bryants line to an elm corner thence with Bryants line to where it Intersects with a line agreed upon by Joseph Sr. & John Mason thence along Masons line to the Beginning To have and to hold the above Granted land & premises and all and singular the rights benefits profits and commodities whatsoever there unto belonging or in any wise appertaining unto the aforesaid lands and premises and the said Zabulon Brinson doth for himself his heirs Exors and Admors them and each of them and against all and every other person warrant and forever defend a good a lawful Tithe unto the said Samuel Welman his heirs and assigns Witness my hand and seal this ninth day of October one thousand eight hundred.

From a chapter of "The Van der Vliet Family in America" (and you probably have this too), it states that Frances, daughter of Princeton's first

settler, Henry Greenland and Daniel, who cam from Devon, England in 1677

aboard ship Willing Mind, first settled in Bucks Co, Penn. In some cases

Daniel's name was spelled Brymson.

Someone sent this to me because of Daniel. Also found this in looking through my notes: Zebulon Brinson of Pittsylvania Co., VA. He was there for a few years around 1780, before heading on to Kentucky.
