Abigail Jett, mentioned in the will of her father, John Jett, who died in Richmond Co., 1710.

Anne Jett, administratrix of Peter Jett, dec'd., 1758, of King George Co.

Anne Jett of Westmoreland Co. (d. 1782) made her will, 1781, mentioning her grandson, Burkett Jett; her son Thomas Jett and his son, William Storke Jett; and her granddaughter, Anne Bernard.

Anne Jett, daughter of Peter Jett (d. 1784) of King George Co., and wife of Conely.

Anne Jett, minor daughter of John Jett who died in Westmoreland Co., 1790.

Anne Jett, daughter of Francis Jett (d. 1791) of Stafford Co., and wife of Archibald Rollens.

Anne Jett, daughter of Peter Jett (d. 1807) of King George Co.

Anne Jett, daughter of Peter Jett, died in King George Co., 1810, testate.

- Birkett (sic) Jett, son of William Jett (d. 1762) of King George Co. He was willed the homeplace purchased of Stephen Bowen and George White, by his father.
- Birkett Jett, son of Birkett Jett (d. 1771), King George Co.
- Birkett Jett died in King George Co., 1771. Will dated 1770. He was a brother of Francis Jett (d. 1766) and of Thomas Jett (d. 1785).
- Burkett Jett, grandson of Anne Jett who died in Westmoreland Co., 1782.
- Birkett (sic) Jett mentioned in the will of his uncle, Thomas Jett (d. 1785) of Westmoreland Co.
- Birkett Jett married Susannah Smith, King George Co., 1789.

- Burkett Jett married Jane Phillips, King George Co., 1801.

- Burkett Jett, Sr. (and Burkett Jett, Jr.) on the Tax Lists, Fauquier Co., 1829.
- Burkett Jett, Sr. (and Burkett Jett, Jr.) on the Tax Lists, Fauquier Co., 1830.
- Burkett Jett, Sr. (and Burkett Jett, Jr.) on the Tax Lists, Fauquier Co., 1831.
- Burkett (and Mildred) Jett on the Tax Lists, Fauquier Co., 1832.
- Burkett Jett appeared alone on the Tax Lists, Fauquier Co., 1834.
- Burkett Jett first appeared on the Tax Lists of Loudoun Co., 1834.
- Burkett Jett on the Tax Lists of Loudoun Co., 1851. (Father or son?)
- Burkett Jett, Jr. (and Burkett Jett, Sr.) on the Tax Lists, Fauquier Co., 1829-31.
- Caty Jett, daughter of Francis Jett (d. 1766) of King George Co.
- Catherine Jett died in King George Co., 1787. In her will (1786) she mentioned her daughters, Betty and Frances Jett and Anne Brown.
- Catherine Jett, daughter of Peter Jett (d. 1807) of King George Co.
- Catherine Jett, sister of Anne Jett (d. 1810) of King George Co.
- Eliza Jett appointed administratrix of Francis Jett, dec'd., 1723, King George Co.
- Eliza Jett, admx. of Francis Jett, dec'd., of King George Co., Eliza, Peter, Francis and Margaret Jett to William Jett, a grant.

- Eliza Jett, daughter of Francis Jett, dec'd (?) of King George Co., with others, above, to William Jett.
- Elizabeth Jett, mentioned in the will of her husband, John Jett who died in Richmond Co., 1710. Query: Was she nee Triplett? The will of Francis Triplett, dated 1700 and probated 1701, mentioned wife Abigail and sons Francis and William Triplett. Francis Jett was a legatee!
- Elizabeth Jett died in King George Co., 1726. Her will, now missing, was presented, Sept. 2, 1726, by Thomas Thatcher, her executor, and proved by the oaths of Luke Tippet and Matthew Martin (O. B. 1, p. 326).
- Elizabeth Jett, daughter of John Jett (d. 1754) of Westmoreland Co.
- Elizabeth, first wife of Col. Thomas Jett (d. 1785) of Westmoreland Co. She was Elizabeth Storke (c. 1726-c.-1774) and married, firstly, 1743, Henry Washington (d. 1748) of Stafford Co., and, secondly, 1749, Robert Vaulx (d. 1755) of Westmoreland Co.
- Elizabeth Jett married William Storke, of King George Co., 1776.
- Elizabeth Jett, daughter of Peter Jett (d. 1784) of King George Co., and wife of Curtis.
- Fenton Jett, daughter of Francis Jett (d. 1791) of Stafford Co., and wife of George Robinson.
- Franky Jett, daughter of Francis Jett (d. 1766) of King George Co.
- Frances Jett, wife of Francis Jett (d. 1761) of King George Co., died 1766 (according to 6 W(1) 247-8).
- Frances Jett, daughter of Catherine Jett (d. 1787) of Westmoreland Co.
- Francis Jett mentioned in the will of his father, John Jett (d. 1710) of Richmond Co.
- Francis Jett (and William Underwood), securities for Elizabeth Underwood, widow of John Underwood (d. 1723) of King George Co.
- Francis Jett of King George Co., was on the Grand Jury, 1723.
- Francis Jett died, intestate, in King George Co., 1723.
- Francis Jett's inventory was filed in King George Co., 1724.
- Francis Jett (son of Francis Jett, dec'd.?) of King George Co., et al., to William Jett, a grant, 1724.
- Francis Jett called "son-in-law" in the will of Anthony Paten (sic) of Westmoreland Co., 1731. Margaret Jett was called "daughter" in this will. Anthony Paten died in 1733.
- Francis Jett received from his father, William Jett of King George Co., 300 acres, land partly in that county and in Westmore-

- land Co., from the estate of his (William's or Francis's?) father, 1754.
- Francis Jett, son of John Jett (d. 1754) of Westmoreland Co.
- Francis Jett died in King George Co., 1761. (according to 6 W (1) 247-8. Will probated 1762, but not listed in Torrence's Index.).
- Francis Jett, son of William Jett (d. 1762) of King George Co., 1762.
- Francis Jett died in King George Co., 1766, testate. He was brother of Burkett Jett (d. 1771) and of Thomas Jett (d. 1785). (According to 6 W (1) 247-8, it was Frances, his widow, who died in 1766 and he who died in 1761!).
- Francis Jett, son of Gladis Jett (d. 1778) of Westmoreland Co., who died in King George Co., 1771.
- Francis Jett, son of Peter Jett (d. 1784) of King George Co.
- Francis Jett's inventory was filed in Westmoreland Co., 1788.
- Francis Jett died in Stafford Co., 1791. At least his will was dated early in that year and is now on file in Fredericksburg, Va.
- Francis Jett, son of Francis Jett (d. 1791) of Stafford Co.
- Francis Jett, minor son of Peter Jett (d. 1807) of King George Co., 1807.
- Francis Jett's estate was partitioned in King George Co., 1808.
- Francis Jett, brother of Anne Jett (d. 1810) of King George Co.
- Gladis Jett of Westmoreland Co., died testate, 1778, in King George Co.
- Isabell Jett, wife of John Jett (d. 1790) of Westmoreland Co.
- James Jett died in Culpeper Co., intestate, 1795.
- James Jett (son of Peter Jett?) received slaves from the latter's estate, King George Co., 1802.
- James Jett, son of Francis (d. c. 1808), King George Co., 1808.
- Jane Jett (daughter of Peter Jett?) received slaves from the latter's estate, King George Co., 1802.
- Jenny Jett, niece of Francis Jett (d. c. 1808) of King George Co., 1808.
- Jeremiah B. Jett, son of Francis Jett (d. c. 1808) of King George Co., 1808.
- John Jett to inherit 170 acres at the death of his brother Peter, without heirs. John had inherited by May 1, 1741. (D. B. No. 1, p. 337, King George Co.). From Richmond Co., 1695.
- John Jett died, testate, in Richmond Co., 1710. Sons Francis, William and John; daughter Abigail. Wife Elizabeth.
- John Jett, Jr., mentioned in the will of his father, John Jett (d. 1710) of Richmond Co., 1710.

- John Jett mentioned in a suit, King George Co., 1722. (same as above?).
- John Jett served on the Grand Jury, King George Co., 1723.
- John Jett died in Westmoreland Co., 1754, testate. Sons: John (to whom he left land in King George Co.), Peter and Francis; daughters Mary, Elizabeth and Anne Jett.
- John Jett, son of John Jett (d. 1754) of Westmoreland Co., willed land by his father in King George Co., 1754.
- John Jett conveyed 170 acres in King George Co., to William Jett, Sr. (another brother?), 1754.
- John Jett, minor son of Peter Jett (d. 1758) of King George Co., 1758.
- John Jett's inventory filed in Westmoreland Co., 1762.
- John Jett appointed Road Surveyor vice Dickie Latham, Culpeper Co., 1763.
- John Jett and Frederick Fishback, "with their gangs to clear the road out of the road that leads from Freeman's to Grinnal's Ford near the school house by Gillison's to his mill," Culpeper Co., 1764.
- John Jett, grandson of Gladis Jett (d. 1778) of Westmoreland Co., 1778.
- John Jett died, testate, Culpeper Co., 1771. Sons: Stephen, John (d. 1808), James (d. 1795), and William; daughters Elizabeth Roach, Margaret Butler and Mary Tapp. His will was dated 1763 and probated 1771.
- John Jett died in Westmoreland Co., testate, 1790.
- John Jett, son of Francis Jett (d. 1791) of Stafford Co., 1791.
- John Jett, son of Peter Jett (d. 1807) of King George Co., 1807.
- John Jett died, testate, 1808, Culpeper Co. His will was dated 1802 and probated 1808. Sons: William, Stephen, James, Joseph and Ninunt (sic); daughters: Anne Churchman, Elizabeth Canady, Sarah Hopper and Abigail Arnold.
- Juda (Judith?) Jett, daughter of Francis Jett (d. 1791) of Stafford Co., 1791.
- Katherine Jett, wife of William Jett (d. 1762) of Loudoun Co. She was nee Newton.
- Katherine Jett and her (late) husband, William Jett, mentioned (1766) in the will of her father, Willoughby Newton (d. 1767) of Westmoreland Co., who had given them land in Loudoun Co., where William Jett died in 1762. Katherine later married John Lane of Loudoun Co.
- Lucy Jett, daughter of Francis Jett of King George Co., married John Harvey of Westmoreland Co., 1807.

- Margaret Jett (daughter of Francis, dec'd., of King George Co.?), et al., to William Jett, a grant, 1724.
- Margaret Jett, wife of Peter Jett of King George Co., 1724.
- Margaret Jett, daughter of Anthony Paten (d. 1733) of Westmoreland Co., and wife of Francis Jett, 1731.
- Margaret Jett died, testate, 1739, Westmoreland Co. Her will mentioned only two granddaughters: Elizabeth and Margaret Morris. Daniel McCarty was her executor.
- Margaret Jett, daughter of Peter Jett (d. 1784) of King George Co., and wife of Thrailkild.
- Mary Jett, daughter of John Jett (d. 1754) of Westmoreland Co.
- Mary Jett called sister in the will of Lawrence Washington (d. 1774) of Westmoreland Co. William Storke Jett was called brother-in-law.
- Mary Jett, daughter of Peter Jett (d. 1784) of King George Co., and wife of Humstead.
- Mary Jett, daughter of Francis Jett (d. 1791) of Stafford Co., and wife of Daniel Sullivant.
- Matthew Jett, son of William and Susan Jett, born, 1779, Culpeper Co. He died in Kentucky March 15, 1854.
- Mildred (and Burkett) Jett appear on the Tax Lists of Fauquier Co., 1828.
- Mildred (and Burkett) Jett on Tax Lists, Fauquier Co., 1832.
- Mildred Jett (alone) on the Tax Lists, Fauquier Co., 1833.
- Nancy Jett, daughter of Francis Jett (d. 1766) of King George Co.
- Nancy Jett, daughter of Birkett Jett (d. 1771) of King George Co.
- Nancy Jett, niece of Anne Jett (d. 1810) of King George Co.
- Newton Jett, minor son of John Jett (d. 1790) of Westmoreland Co.
- Newton Jett married Catherine Suttle Hudson, King George Co., 1805.
- Peggy (Jett) Bartlett executrix of (her father?) William Jett (d. 1791) of Westmoreland Co.
- Peter Jett was left 170 acres by the will of his father, 1695, Richmond Co. He died, without issue, before 1741, when his brother John inherited.
- Peter Jett was security for Margaret James, widow of Francis James (d. 1721) of King George Co.
- Peter Jett was on the Grand Jury, King George Co., 1723.
- Peter Jett (son of Francis Jett, dec'd.?) of King George Co. et al., to William Jett, a grant, 1724.
- Peter Jett of King George Co., made his will (1728) which was probated in Westmoreland Co., 1739. Wife Margaret.

- Peter Jett, son of John Jett (d. 1754) of Westmoreland Co.
 Peter Jett's estate appraised in King George Co. Anne Jett, administratrix, 1758.
- Peter Jett, minor son of Peter Jett, dec'd., 1758, King George Co.
 Peter Jett and Rebecca (his wife?) were willed the entire estate of Susanna Bowen (d. 1761) of King George Co.
- Peter Jett, son of Gladis Jett (d. 1778) of Westmoreland Co., who died in King George Co., 1778.
- Peter Jett died 1777, King George Co. Will.
- Peter Jett died 1784, King George Co., Brunswick Parish. Will.
- Peter Jett was executor of the estate of Catherine Jett (d. 1787) of Westmoreland Co.
- Peter Jett, son of Francis Jett (d. 1791) of Stafford Co.
- Peter Jett died, 1807, in King George Co. Will.
- Rebecca Jett (wife of Peter Jett?) was co-heir, with Peter Jett, to the estate of Susanna Bowen (d. 1761) of King George Co., by her will.
- Sarah Jett, daughter of Peter Jett (d. 1784) of King George Co., and wife of Jones.
- Sarah Jett, daughter of Francis Jett (d. 1791) of Stafford Co., and wife of Presley Cox.
- Stephen Jett et al., versus James Pendleton, late Sheriff of Culpeper Co. The others were: William Eastham, Henry Pendleton, Thomas Slaughter, Robert Freeman and John Williams. "Continued." 1763.
- Stephen Jett, son of Peter Jett (d. 1807) of King George Co.
- Stephen Jett, brother of Anne Jett (d. 1810) of King George Co.
- Sukey (i. e., Susannah) Jett, widow of Col. Thomas Jett (d. 1785) of Westmoreland Co. She was Susannah Washington (1745-1822), widow of Lawrence Washington (1744-1774). She married, thirdly, Col. John Skinker (d. 1798?) of King George Co. She was the second wife of Col. Thomas Jett.
- Susannah Jett, daughter of Francis Jett (d. 1791) of Stafford Co., and wife of William Burton.
- Thomas Jett, administrator of the estate of Sarah Stone (d. 1752) of King George Co.
- Thomas Jett, son of William Jett (d. 1762) of King George Co.
- Thomas Jett, brother of Francis (d. 1766) and of Burkett Jett (d. 1771), both of King George Co.
- Thomas Jett, son of Anne Jett (d. 1782) of Westmoreland Co., 1781.
- Thomas Jett died, 1785, Westmoreland Co.

- Thomas Jett, son of Francis Jett (d. 1791) of Stafford Co. He married, Jan. 12, 1775, Lucinda Owens of St. Paul's Parish, now King George Co.
- Thomas Jett married Nancy Wilkerson, 1796, King George Co.
- William Jett(e) of Accomac, later of Rappahannock Co., married Elizabeth, daughter of Anthony Hoskins of Accomac Co., before May 17, 1681. (Book 6, p. 262). He later lived in Richmond Co., and died there in 1698, but his will, dated 1695, is now missing. It was proved, July 6, 1698, by William Underwood and George Green (Book 2, p. 331).
- William Jett of Westmoreland Co., 1692, had land adjoining Joseph Beckley, Tobias Butler and Robert Andrewes.
- William Jett was mentioned in the will of his father, John Jett (d. 1710) of Richmond Co.
- William Jett of King George Co., from Eliza Jett et al., a grant, 1724. Query: Was he a son of Francis Jett, dec'd.?
- William Jett, Sr., conveyed 170 acres to his son, William Jett, Jr., of King George Co., 1754.
- William Jett to his son Francis Jett, 300 acres in King George and Westmoreland Counties from the estate of his father, Francis Jett, dec'd. King George Co., 1754.
- William Jett of King George Co., 50 acres from George White from the latter's grandfather, John Burkett, whose daughter, Eliza Burkett, was the mother of the said White, 1755. (N. B. the surname Burkett in the Jett Family).
- William Jett gave Thomas Turner a home for ten years, 1757, King George Co.
- William Jett to his son, William Jett, Jr., 100 acres in King George Co., part of a tract of land bought from George White, 1759.
- William Jett, Sr., died, 1762, King George Co. Wife Anne.
- William Jett, Sr., dec'd. Inventory filed, 1762, King George Co.
- William Jett born, 1763. He was living in Culpeper Co., in 1840.
- William Jett died, 1801, Culpeper Co., testate. Will dated 1799, probated 1801. Wife Susanna. Sons Edgar and Matthew; daughters: Milly (wife of William Jett), Molly (wife of William Williams), Margaret (wife of James Withers Downey, Betsy (wife of William Whitehead), Phoebe (wife of the above Downey?), Anne, Susanna and Dicey Jett.
- William Jett, Jr., received 100 acres in King George Co., from his father, William Jett, Sr., 1759.
- William Jett, Jr., Quartermaster of Militia, Loudoun Co., 1761. (d. 1762).
- William Jett, son of William Jett (d. 1762) of King George Co.

William Jett and Katherine, his wife, of Loudoun Co., land, 1759, from William Jett, Sr., of King George Co., 1762.

William Jett died, intestate, in Loudoun Co., 1762; wife Katherine (nee Newton).

William Jett, son of Birkett Jett (d. 1771) of King George Co.

William Jett, son of Peter Jett (d. 1784) of King George Co. He died in King George Co., before 1792.

William Jett died, testate, in Westmoreland Co., 1791. Anthony Payten was his executor. (Cf. Anthony Paten who died, 1733, in Westmoreland Co.).

William Eskridge Jett, son of William Jett (d. 1762) of Loudoun Co.

William Storke Jett, born in Westmoreland Co., 1763. He died in King George Co., 1844. He was a Revolutionary Officer and pensioned. He was born in that part of Westmoreland which later became King George Co., and was a son of Col. Thomas Jett by his first wife, Elizabeth Storke.

William Storke Jett was called brother-in-law in the will of Lawrence Washington (1774) of Westmoreland Co. By "brother-in-law" often step-brother or half-brother was meant.

William Storke Jett, son of Thomas and grandson of Anne Jett who died in Westmoreland Co., in 1782.

William Storke Jett mentioned in the will of his father, Thomas Jett (d. 1785) of Westmoreland Co.

William Storke Jett married Jane Turner, King George Co., 1803.*

William Storke Jett, Sr., from William Storke Jett, Jr., $\frac{1}{4}$ interest in the estate of Joanna Murdock, wife of Jett, Sr., of King George Co., 1812.

William Storke Jett, Jr., to William Storke Jett, Sr., his father, $\frac{1}{4}$ interest in the estate of his mother, Joanna Murdock, King George Co., 1812.

ADDENDA

Alex(ander) and Birkett Jett witnessed the will of Francis Jett, King George Co., 1766.

Anne Jett married Francis Stone. William Jett, security. Westmoreland Co., 1786.

Anne Jett died in 1810. Will recorded in King George Co. Brothers Stephen and Francis; sister Catherine; niece Nancy.

Birkett and Alex(ander) Jett witnessed the will of Francis Jett, King George Co., 1766.

*This was his second marriage; he married, firstly, 1792, Joanna Murdock of King George Co.

- Birkett Jett witnessed a deed from Catherine, extrx., of Francis Jett, dec'd., to Richard Payne and Anthony Peyton, King George Co., 1768.
- Birkett Jett died 1771. Will mentioned son William; daughters Nancy and Betty; wife (unnamed); brother Thomas. King George Co.
- Catherine Jett, "only acting executrix of Francis Jett, dec'd.," to Richard Payne and Anthony Peyton, all of King George Co., 1768.
- Francis Jett of Richmond Co., to Frances James of Westmoreland Co., 300 acres, $\frac{1}{2}$ of a patent granted to Peter Jett, Jan. 21, 1666, then in Rappahannock Co.
- Francis Jett voted at an election for Burgess, Westmoreland Co., 1752.
- Francis Jett of King George Co., from Samuel Reeds of Culpeper Co., 100 acres near the Little Falls of the Rappahannock, 1761.
- Francis Jett, orphan of John Jett, dec'd., a ward of Peter Jett, Westmoreland Co., 1762.
- Francis Jett, son of John Jett, dec'd., received his share of his father's estate, Westmoreland Co., 1762.
- Francis Jett, Jr., to Richard Payne, both of King George Co., a mortgage on his land, 1762.
- Francis Jett died 1766. Will mentioned daughters: Nancy, Betty, Caty and Franky; brother Thomas, exor. Witnesses: Birkett and Alex(ander) Jett. King George Co.
- Francis and William Jett witnessed the will of William Bowen, King George Co., 1771.
- Francis Jett from Joseph Hart and Alice, his wife, 200 acres, King George Co., 1784.
- Francis Jett, dec'd. Estate divided between his widow, William Brown as husband of Anne Jett, Betsy and Frances Jett. (See the will of Catherine Jett.) Westmoreland Co., 1787.
- Francis Jett died in Stafford Co., 1791. (He was a son of Peter Jett who died in King George Co., in 1784.)
- Francis Jett and Betty, his wife to Boddington Frank, all of King George Co., 150 acres purchased of Joseph Hart, 1792.
- Francis Jett married (License, Dec. 19, 1797), Sally Simms. William Jett, security. Westmoreland Co.
- Gladis (widow of John) Jett died 1778. She was of Westmoreland, but her will is recorded in King George Co. Sons: Peter and Francis; grandson, John, son of Peter; daughters: Nancy Hardwick, and Elizabeth Mothershead; son-in-law, William Piper.

- James Jett married (License Feb. 25, 1805) Nancy, daughter of Thomas Muse (whose widow, Frances, married Thomas Berryman). Westmoreland Co.
- John (brother of Francis) Jett was an appraiser of the estate of George Payne, Richmond Co., 1711.
- John Jett was a security for John Payne, Richmond Co., 1714.
- John Jett from Original Brown and Elizabeth, his wife, all of Westmoreland Co., 150 acres near the head of Mattox Creek, 1728.
- John Jett of King George Co., bought land near the head of Mattox Creek from John Reeds of Westmoreland Co., 1731.

- John Jett of King George Co., 200 acres in that county from French Mason of Prince William Co., 1739. Land where the said John Jett lives. Lease for one year.
- John Jett of Westmoreland Co., and John Jett, Jr., of King George Co., to John Triplett of Westmoreland Co., 100 acres on Mattox Creek, 1741.
- John Jett of Westmoreland Co., to William Jett of King George Co., 170 acres willed (1695) by William Jett to (his son) Peter Jett and, failing heirs of the said Peter, to revert to his brother, John Jett. Peter was dead by 1741 and John had inherited.
- John Jett of Westmoreland Co., 100 acres from John Triplett of King George Co., 1749.
- John Jett died in Westmoreland Co., 1754. (He was a son of William Jett who died 1698).
- John Jett, son of Peter Jett (dec'd?) apptd (apprenticed?) to Nicholas Quisenberry, King George Co., 1761.
- John Jett, dec'd. Estate divided between Mrs. Gladis Jett, Mr. William Piper, Peter and Francis Jett. Westmoreland Co., 1762.
- John Jett married (License, March 10, 1789), Frances James, Westmoreland Co.
- John Jett died in Westmoreland Co., 1790. Will mentioned sons: Newton and Birkett; daughter Anne; wife Isabel.
- John Jett of Fauquier Co., 1792.
- Molly Jett married Robert Massey. William Jett Security. Westmoreland Co., 1793.
- Peter Jett married Rebecca (Bowen?), King George County, 1734/5.

- Peter Jett of King George County from Henry Fitzhugh of Stafford Co., 100 acres for the life of the said Peter, Rebecca, his wife, and Francis, his son, 1737.
- Peter Jett, dec'd., Westmoreland Co., 1740. Inventory returned.
- Peter Jett was a bondsman for William and Matthew Bowen, executors of Stephen Bowen, dec'd., King George Co., 1749.
- Peter Jett, dec'd. Estate divided between his 5 children: James, son and heir; William, Mary, Peter and John Jett. Anne Jett, widow, was guardian of Peter and John Jett. Thomas Jett was her bondsman. King George Co., 1758.
- Peter Jett, son of John Jett, dec'd., received his share of his father's estate, Westmoreland Co., 1762.
- Peter Jett, a Revolutionary Soldier, King George Co., made his will, 1777. He left to Augustine Jett his wearing apparel.
- Peter Jett died in King George Co., 1784. Will mentioned daughters: Anne Connely, Mary Humstead, Sarah Jones, Margaret Threlkeld and Eliza Curtis; grandson, Jesse Threlkeld; sons William and Francis Jett.
- Peter Jett died in King George Co., 1807. Will mentioned sons: Stephen, William and Francis (minor); daughters: Anne and Catherine.
- Stephen Jett married (License, May 15, 1805) Elizabeth D. Muse, daughter of Thomas Muse (*supra*). Westmoreland Co.
- Susanna Jett, daughter of Peter Jett (d. 1784), married Francis Payne (d. 1816), King George Co., 1766/7. She died, 1820, in Fauquier Co.
- Thomas Jett witnessed a deed of gift from William Jett to his son, Francis Jett, King George Co., 1750.
- Thomas Jett and William Bernard of Westmoreland Co., from Francis Williams of the same co., 400 acres and negroes to secure a debt, 1768.
- Thomas Jett married (License, Nov. 25, 1793), Peggy Berkeley, Samuel Berryman, security. Westmoreland Co.
- William Jett (son of Francis Jett), administrator of John Payne, dec'd., King George Co., 1725/6.
- William Jett of King George Co., from John Jett of Westmoreland Co., 170 acres in King George Co., 1741.
- William Jett of King George Co., to his son, Francis Jett, deed of gift of 300 acres in Westmoreland and King George Counties, land inherited from his father, Francis Jett, dec'd., whose eldest son and heir he (William) was, 1750.
- William Jett, Sr., to his son, William Jett, Jr., 170 acres purchased from John Jett in 1741, King George Co., 1757.
- William Jett died in King George Co., 1762. Will mentioned sons: Francis, Thomas, William and Birkett; wife Anne.

- William and Francis Jett witnessed the will of William Bowen, King George Co., 1771.
- William Jett, Jr., witnessed a deed of gift from William Jett to his son Francis Jett, King George Co., 1750.
- William Jett was security for Nancy Jett to marry Isaac Stone, Westmoreland Co., 1786.
- William Jett was security for Molly Jett to marry Robert Massey, Westmoreland Co., 1793.
- William Jett was security for Francis Jett to marry Sally Sims, Westmoreland Co., 1797.
- William Jett married (License, Nov. 25, 1807), Catherine White, Westmoreland Co.
- William Jett married (License, Dec. 14, 1809), Nancy Thomas, Westmoreland Co.
- William Jett, Jr., married (License, March 3, 1805), Phoebe, daughter of Patsy Short, Westmoreland Co.

The foregoing notes are offered in the form of an index with the hope that they will assist searchers and descendants by showing the places of residence of various Jetts of Virginia during the period from 1681 to 1851, all of whom seem to form one family descending from William Jett of Accomac and (later) Rappahannock and Richmond Counties (d. 1698).
