

I, Margus Selin Lord of Lincoln County N.Y. do hereby make my last
 Will and Testament in manner and form following That is to say
 1st I desire that all the personal part of my estate be immediately
 sold after my decease and out of the monies arising therefrom all
 my just debts and funeral expenses be paid
 2nd I give to my son Charles Selin the plantation where he now lives
 on in Washington County on the Salisbury also one hundred
 acres of land and on the south side of the River joining of the
 point he lives on. 3rd I give to my son John Selin that I had
 by my 2nd wife Nancy Thomas as was the balance of the tract
 of land that lies on said Salisbury in Washington County
 he is not to have a weight of any land until he arrives at age
 of twenty five years of age. 4th I give to my two sons John & Margus Selin
 and Meredith Selin that I had by my second wife Nancy
 Thomas as was the plantation that I now live on & Margus to have the
 north end and Meredith the south end the meadow house and
 it is to be equally divided quantity & quality Margus Selin and
 Meredith Selin is to make Charles Selin and John Selin land that
 lies in Washington County equal in value to their land that lies
 in Lincoln County provided that the land in Washington County
 should be lost as it is now in law the said Charles and John is to
 have an equal share of land in Lincoln County with Margus &
 Meredith it is to be understood that Margus is not to have a right to
 his part of the land till he is twenty five years of age or more
 5th I give to my daughter Betty Kings five hundred Dollars also my
 daughter Selin Selin that I had by my second wife Nancy Thomas
 as was said hundred Dollars it is also my wish that my daughter
 Betty Kings take my daughter Selin and take care of her as long
 as she lives and to be paid thirty Dollars per year out of my
 estate and if Betty will not take her my son Charles must
 take her for the same. 6th The balance of my estate if any is to
 be equally divided among all my children it is also my wish that
 Charles take my daughter Selin and Meredith and other monies
 to the use of home also Charles is to have all my negroes and
 keep them for his benefit for schooling Meredith until his coming
 of age and then they are all to be sold but Letty and she is
 to be free and the money arising therefrom is to be equally
 divided. 7th I wish my plantation that I live on be rented

But until my son Margus Dehn becomes of age and the money arising therefrom be put out on Interest also all the money that now falls in the hands of the Executors over and above what will pay all my past debts is to be put out on Interest until my son becomes of age. Also I wish my son Mordecai to have a horse worth one hundred Dollars bridle & saddle, and lastly I do hereby constitute & appoint my friends Albin Milton John Thomas and my son Charles Dehn Executors of this my last Will and Testament thereby revoking all other or former wills or testaments by me ~~made~~ heretofore made.
