IN THE NAME OF GOD, Amen. I JOHN HARGIS of Westmorland County in Virginia doe make this my Last Will as followeth; Item. I give unto my Son, JOHN HARGIS, my Negro woman called Nan and her futer increase.

Item. I give two fether bades to my Son, JOHN, one black hors named Punch. Item. I give two Mares on brake and there Increase. I give two Cows and Calves. Item. I give ten puter bacons, fourteen puter plates and five puter dishes. Item. I give my Son, JOHN, one Gun.

Item. I give to my Dafter, MARY HARGIS, two fether bades, one barn Cow and one pide Hefer;

Item. I give to MARY one young Mare bread in Enons Old Feelds;

Item. I give to my Dafter, MARY, five dishes and fifteen plates, nine puter basons.

Item. I give to my Dafter, MILESITT HARGIS, five shillings Sterling money to be paided her by my exters. All the rest of my pasnebel Estate I give to my Son and Defter, MARY HARGIS to be equilly devided between them. My desire is that they should be of age at my death and to dweell upon the Plantation I live on, I doe apint my Brother, ROGER HARGIS, and JAMES WORING my Executors of this my Last Will and Testament oneing this to be my Last Will and Testament, revoking all other Wills whatsoever by me made. Signed & Sealed in the presence of us. Signed & Sealed by me this 19th day of June Anno 1730.

 Nov. 19, 1685 - The Charles County, Md. will of William Hargis, probated Mar. 16, 1685/6, leaves:

-to wife Ann, executrix, goods, chattels, land or whatsoever;

-to son John Draper, 1 sow/cow;

-to son Roger, 1 mare;

-to son William, 1 English shilling.

Signed William Hargis ("H" his mark.)

Witnesses: John Draper, Oliver Rochefort, Elizabeth Huskola.
