CAMPBELLS OF DUNTROON From "Canberra's First Hundred Years and After."

Robert Campbell, commonly referred to as "Merchant" Campbell of "The Wharf," Sydney, to distinguish him from at least three others of the name, was born in 1769, as younger son of the last Laird of Ashfield, in Argyllshire, Scotland. As the Ashfield family was a younger branch of the Campbells of Duntroon Castle (standing on Loch Crinan in Argyll), he was thus also a "Cadet of Duntroon," and is proudly proclaimed to be such on his monument in St.

Philip's Church, Sydney.
Robert Campbell came to Sydney in 1798 from Calcutta. He had five sons namely: 1. John 1802-1886, 2. 1809-1888, 4. George married Marriane Collinson, 5.

Earl of Argyle is commissioned to root out and expatriate "The MacGregor Clan" (The Duke of Argyle is head of the Campbell Clan), "The Scotch Irish in America" by Henry James Ford, p. 85. THE CAMPBELL FAMILY

The following genealogical table is compiled largely from data found in historical papers owned by Washington and Lee University, at Lexington, Virginia. DUNCAN CAMPBELL-

The following is a quotation from an address by the Hon. Hugh Blair Grigsby, L.L.D., entiled "The Founders of Washington College," delivered June 22, 1870:

"Duncan Campbell, who never left Scotland, had three sons, Dougald, Robert and who removed to Ireland in 1700 and settled in Coleraine, in the county of Derry. Most of the descendants of these three brothers, between 1730 and 1740 emigrated Pennsylvania and thence came to Augusta (Augusta, Va.), as Augusta then was. The descendants of Dougald are said to have settled in what is now Rockbridge. Many of John's descendants are to be found in Washington county. Three brothers, sons of Robert, namely, Hugh, John and Charles, settled in Augusta proper."

Duncan Campbell married Mary McCoy 1672.

CHARLES CAMPBELL

Son of Robert. Married in 1739 to Mary Trotter. Their children were Robert, Hugh, John, Charles, James, Joseph, William. Elizabeth and Mary.

CHARLES CAMPBELL,

Son of Charles; born in Rockbridge in 1741; married to Mary Ann Downey in 1764. Both husband and wife lived to advanced age, she dying in 1834 at the age of 82, and he dying in 1826 at the age of 85. Charles Campbell was among the Presbyterial Trustees of 1776 and also the Charter Trustees of Washington College. The following quotation is taken from the address of Dr. Grigsby, above referred to:

"Charles Campbell did not actively embark in political affairs, but commanded a

company at the siege of York: and he delighted in old age to recount the details of the siege. He was noted for his piety, was fond of books, encouraged literary institutions, and trained his numerous sons and daughters in sound learning. One of his sons, Dr. Samuel L. Campbell, who was a pupil of the academy, a trustee, and for a short period its rector, was a good scholar and a correct and graceful writer; and we owe to his pen not only a graphic account of the infant academy and of its early pupils, but a valuable historical memoir of the battle of Point Pleasant. Charles Campbell, your trustee, who lived as late as 1826, is well remembered by many now living. He was about middle size; and in his old age, as he sat as an elder in the New Providence church, on the left of the pulpit, with his white hair flowing, decrepit with years, but firm in faith and zealous for the glory of God, he was a striking figure. He was long a Magistrate, and did not hesitate to use the whole rigor of the law in repressing violations of the Sabbath. At your annual celebrations the good old man drove from his residence twelve miles distant to this hill in his carriage drawn by two rather old white horses, who rejoiced the names of Grey and Goody, and listened with rapt attention to all the ex

SAMUEL L. CAMPBELL.

Son of Charles. Was born ... bridge county. He entered Washington college in 1782, graduating in 1789, and the following memorandum with reference to him is found in the Catalogue of the Officers and Alumni of Washington and Lee University:

Samuel L. Campbell, M. D., Rockbridge county, Trustee of Washington College 1794 to 1812. Distinguished physician. Died 1840. Samuel L. Campbell was married September 19, 1794, to Sarah married September 19, 1794, to Sarah Alexander, sister of Rev. Archibald Alexander, D. D., afterwards president of Princeton College. Their children were: Sophia, born June 22, 1795; Nancy, born May 9, 1798; Mary Ann, born May 25, 1801, died September 20, 1802; Charles Fenelon, born September 13, 1803; William M. born Lune 9, 1005. Sanuti, born Anti-M., born June 9, 1805; Samuel, born April 10, 1807; Sarah, born November 2, 1809; Augusta, born September 9, 1812, died in August, 1813; John, born April 17, 1815; Archibald, born October 11, 1816, died in July, 1822.

Samuel L. Campbell was connected with Washington College and Washington and Lee University as rector of the board of trustees from 1797 to 1799, and as trustee from 1794 to 1812. He was treasurer of the college from 1796 to 1803, and president of the faculty from 1796 to 1799. Two of his sons were graduates of the institution, of whom the following memorandum appears in the Catalogue of Officers and Alumni of Washington and Lee University: "Charles Fenelon Campbell, A. B., Rock-

bridge county. Removed to Ripley, Ohio, afterwards to Georgetown; Lawyer, editor probate judge. Died September 2, He graduated from Washington and probate judge. College with the class of 1822-23.

"William M. Campbell, A. B., Rockbridge county, lawyer Removed to St. Charles, Missouri. A member of the Missouri House of Delegates from 1831 to 1835. Missouri Senate from 1835 to 1845

and from 1847 to 1850. Member of the Missouri Convention. Removed to St. Louis. Editor of the evening Gazette. Lawyer and statesman of eminent ability. Died 1850. CHARLES FENELON CAMPBELL

Born September 13, 1803, at Lexington, Died at Georgetown, Ohio, September 2, 1864. Married to Harriet E. Kephart, of Ripley, Ohio, on the 12th of September, 1833. Graduated at Washington College in his twentieth year, admitted to the bar as attorney and solicitor in chancery for Brown county, Ohio. Practiced his pro-fession until his death, becoming eminent as a furist throughout southern Ohio. Published the Whig, and later the Ripley Bee, of Ripley, Ohio. He received a military education at the Military Institute of Lexington, Va., and when the Rebellion broke out he was commissioned by the Governor of Ohio to organize the militia of his sec-tion of the state. His labors in this capacity brought on the disease which resulted in his death. He was an astute lawyer and an able and impartial judge.

of Glenorchy, was joined with the Earls of Morton, Gowrie, and others in estab-lishing the policy of the Church and Gov-ernment in 1573, and in 1580 he built the Castle of Balloch, so called from the Gaelic word said to mean the outlet of the loch, and now named "Taynputh." By the loch, and now named marriage into the family of Tosach, his 4th Archibald, obtained the estate Monzie, but died without heirs and his daughter Beatrice, became ancestress of

Campbells of Lawers and Louden. Sir Duncan, 5th of Glenarchy in 1617, was made Keeper of the Forests of Mamlorn, Finglenmore, and others and was made a Baronet of Nova Scotia in 1627. His 2nd son became Sir Robert Campbell of Gien-Failoch, and his 3rd son, Archibald, became the ancestor of the families of Monzie, Lochlan and Finab. Sir Duncan who was known as "Donacha Dubh na Curraichd, or Black Duncan of the Cowl. was a patron of Jameson, the Vandyke of Scotland, and was eminent for his taste in building and planting. (Black Book of Taymouth). He d. in 1631. Sir Colin, his son and successor, married Julianna Campbell, day of the Earl of Loudon, and outrivaled him in his taste of Elegant things, and employed a German painter to paint thretty brods of the Kings of Scotland. Great Britain, France, and Ireland" (ibid). dying in 1640, he was succeeded by his brother:-Sir Robert Campbell, previously Glenfalloch, who married Isobel, day. of Machlan MacIntosh, chief of the Clan Chattan.

Sir John Campbell, 8th of Glenorchy, vas a man of great capacity, and was deemed an able statesman in his time, but he was destitute of all scrupple. He was loyal to Charles II, and was created Earl of Caithness in 1677, by a quibble of trickery to be related elsewhere, and empowered by the Scotch Privy Council. He marched to take possession of the patrimony of the Sinclairs, with whom in he fought the bloody battle of Altimarlach. Over this usurpation, a sense of justice prevailed, and to pacify him, in 1681, he was created Earl of Breadalbane and Holland. He was in great favor with King James VI. was bitterly opposed to the Union and it is said he was on the point of joining the Earl of Mar in 1715. He died in his 81st year. John, 2nd Earl of Breadalbane, was a

representative in 1734 and 1741, and John, 3rd Earl, was in his earlier years, Master of the Horse to the Princess Royal in 1718 Envoy Extraordinary to the Court of Denmark in 1720. He died in 1782 without issue, when the Earldom went to his distant cousin John, Grandson of Colin, third son of the above named, Sir Robert Camp-bell, previously of Glenfalloch. The 4th was created Marquess of Breadalbane in 1831, and died in 1834, leaving a son John, 2nd Marquess, but he dying without issue in 1862, the Earldom went to his cousin John, a descendant of William Campbell of Glenfalloch, 5th sor, of the above named Sir Robert. The 6th Earl died in 1871, and was succeeded by his son, Gavin, 7th Earl, who was created a marquis of Breadalbane in 1885.

The first Campbell of the line of Cawdor was Sir John Campbell, third son of Archibald, 2nd Earl of Argyll, who married Muriel, daughter and heiress of Sir John Archibald Cawdor (or Calder) of that ilk, who died in 1498. Her Uncles resolved if they could to set her aside, and with the aid of a kinsman, the Precentor of Ross, they brought forward some curious evidence to prove her illegitimate. But the little Muriel was not unfriended. Her estates held of the Crown, thus the King bestowed her ward and marriage upon the Earl of Argyll, a powerful guardian, who in her 12th year bestowed her as a bride on his third son, John in 1510.—a marriage that had many advantages, and perhaps no other alliance in Scotland could have enabled the young heiress to hold her own among rough and hostile neigh-

bors.
"He was a Campbell of the old stamp," says the Book of the Thanes of Cawdor, "Seeking incessantly to increase his pos-sessions and influence." His treaties with cousins of his own class, with the Mac-Leans, the MacDonalds, the MacNeills show both his policy and his acknowle edged power-His possessions in Argyll are large and interesting. He seems already to have pretended some right to Isla. The grim keep of Cawdor, with it's turrets and rambling out-works is one of the most remarkable edifices in Scotland. and among some sculpture on a stone date 1510 the year of Muriel's marriage is carved a fox smoking a short tobacco pipe, 75 years before Sir Walter Raleigh introduced smoking into England. (It was some-

what longer than that, I think, 1609, etc.)
From 1524 till 1546, the year of his death, Sir John Campbell resided permanently at Cawdor. Lady Muriel survived him long, also their son, Archibald. She died in 1573 resigning her thanedom in favor of her grandson, John, who married Mary Keith, the daughter of an opulent, noble, and honorable family, the Earl Marischal. The Reformation brought the accession of the Prior lands of Ard-

Lady Cawdor, being a sister of the Countess of Argy!l, on the death of the Earl in 1584, Sir John Campbell was one of the 6 persons named to manage the Earldom during the young peer's min-
