According to F. Z. Saunders: Morris Veale was found in Westmoreland Co., VA by 1669. He died between 3 Oct. 1695 when he wrote his will and 29 July 1696 when it was probated in Westmoreland County, VA. F. Z. Saunders's transcription of the Morris Veale will appears on his website. The will divides his land and plantation among 3 sons: Morris, John and William, all apparently minors at the time of writing. Daughter Amey, daughter Elenor, and daughter Mary are also named in the will; wife Dorothy is named executor. "Loving friends and neighbors" Darby Sullivant, Richard Hencock, and Toias Butler are named trustees and overseers for the children.
